# MEETING MINUTES PUBLIC WORKS COUNCIL COMMITTEE

## West Des Moines City Hall Training Room December 7, 2015

Meeting called to order at 11:33 am.

#### 1. 100 Block of 7th Street Access

#### Issue Summary:

Principal Engineer Jeff Nash requested subcommittee recommendation at the November 23, 2015, PWCC meeting regarding the issue of rights of way (ROW) along the 100 block of 7<sup>th</sup> Street between the sidewalk and street which are currently being used for parking. The topic was deferred for two weeks. 7<sup>th</sup> Street from Railroad Avenue to Maple Street is proposed to be reconstructed in 2016, during which time the City typically removes ROW areas used for parking. There have been just two exceptions in the past fifteen years. The street is proposed to be reconstructed at a width of 26 ft. in accordance with City Code. Currently the street is 24 ft. wide, and 20-21.5 ft. in the ROW areas where parking is taking place. A 2-foot overhang is required next to sidewalks. Mr. Nash feels there is not room to provide angle or straight-ahead parking, but possibly parallel parking could be accommodated.

Concerns expressed by Councilman Kevin Trevillyan are that because of its uniqueness, the Valley Junction area should possibly be treated differently than other parts of the City; parking in the ROW areas has taken place for many years with no issues or citations; the affected property owners will be forced to put in driveways and, should that occur, gravel vs. concrete could be allowed.

During the design process of the 7<sup>th</sup> Street reconstruction project property owners will have an opportunity to express concerns or request exemptions. The project area is currently in the process of being surveyed.

**Direction:** PWCC recommends that the project survey be completed, numbers be compiled regarding roadway and ROW measurements for determination of a recommendation, and that staff then reach out to property owners and residents explaining the project and asking for input. If no issues are initiated by property owners, the project should proceed. If issues are presented by property owners or residents, the issue should come back to the PWCC for recommendations.

## 2. <u>Valley Junction District Handicapped Signs</u> <u>Issue Summary:</u>

Traffic Engineer Jim Dickinson reported that a business owner has requested a handicapped parking spot be added on the west side of 5<sup>th</sup> Street in front of her business to accommodate her elderly mother. It was explained to the business owner that any handicapped parking spot on a public street is available to the general public. A handicapped parking spot requires a five ft. aisle for van accommodation, therefore requiring two regular parking places. An overhead view of the Valley Junction area was shown with handicapped parking spots identified. 2% of parking spots are required to be handicapped, and the City meets this criteria. No complaints have been received regarding handicapped parking, with the exception of this request. It was noted that the handicapped parking spots in Valley Junction do not appear to be placed in a consistent manner, with a number of them in parking lots behind businesses which may not be convenient. Any reconstruction of parking spaces would not occur until the next construction season.

**Direction:** The PWCC recommends deferring this issue until a future date.

The Bicycle Advisory Commission is in agreement with Staff's recommendation to not construct bicycle lanes as part of the Ashworth Road widening project.




