On Item 4A. Veterans Parkway / Great Western Trail Update (Informational Item Only)
Ortgies shared that an open house is scheduled for 5-7pm on March 9. She added that the roadway construction in proposed option E2 will not touch the Great Western Trail or the trail corridor but may have a greater impact on several adjacent landowners.

Committee Reports:

On Item 6A. Education and Encouragement Committee

Eddy shared that the Committee met and discussed upcoming events like Bike Night in Valley Junction, Mayor's Bike Ride and National Trails Day. Eddy shared that the WDM Leadership Academy is having a Safety Expo in April and will be handing out 500 bike helmets. Eddy noted that the Committee was also able to review the first draft of the Iowa Bicycle Coalition's Ride Right, Ride Responsibly curriculum which will eventually be implemented in local schools through their physical education programs. Hansen attended the Bike Expo and handed out information related to WDM Parks & Recreation programs and events. Ortgies shared that 2017 goals are to promote and grow existing events and implement the Ride Right curriculum.

Alvarez shared 2016 trail counter data. Alvarez noted that the current counters were on loan from the MPO but that the City has purchased their own from the same manufacturer that will be installed in the same locations to continue to obtain data.

Wolcott inquired about the connection loop trail that was published in the Des Moines Register. Ortgies gave background information about the Park Board's work on some larger "dream" projects which were presented to City Council in February. She added that she will plan to make the same presentation to the Bicycle Advisory Commission at an upcoming meeting. France shared that he met with Senator Charles Schneider about minimum passing distance legislation. France has also been in contact with Mark Wyatt of the Iowa Bicycle Coalition regarding lighting laws for bicycles. France encouraged ongoing discussions on these topics. Eddy shared that a new B-Cycle station was unveiled at the new downtown Hy-Vee.

On Item 8B. Recognition of Outgoing Commissioners – Steve Gatton / AJ Kelley Gatton shared that getting the Bicycle Master Plan and Complete Streets Policy were important steps to make the community more bike friendly and encouraged remaining Commission member to continue to move forward. Kelley echoed Gatton's comments and shared her excitement in seeing the progress that has been made and will continue to be made. Eddy thanked them both for their dedication to the Commission.

Todd Seaman introduced Pat Boddy, and Ryan Peterson of RDG, who presented on the recently completed Clive Greenbelt Master Plan. Recognizing the trail's importance as both a local and regional asset, RDG presented on the structure and content of the plan as well as how it relates and impacts the work of the Roundtable. The plan covers a number of topics including stormwater and floodplain management, connecting the trail to the community, health impacts, economic development opportunities, and social connections.

The Roundtable is encouraged to look at the full document and use it as a resource when considering trail design, relevant policies, water management strategies, and similar projects. Clive is representative of many challenges the entire region is facing and this document can provide a starting point for future conversations.

6. DISCUSSION: Trail Counter Update

Staff presented on updates to the trail counter program. The newly purchased counters will arrive shortly and will be ready for the spring. The MPO is also conducting an inventory of existing counters in use, and looks for members to disclose the condition of any MPO, CIRTPA, or locally owned counters currently in place. The MPO will also look to update the overall counter program and look to evolve the system from a first-come first-served program to more strategic

plan for placing and rotating counters throughout the region. Finally, the MPO is preparing its annual trail use report and requests that anyone with relevant data please send it to MPO staff.

8. Other Non-Action Items of Interest to the Committee

The Roundtable shared info on several topics. The first is that the City of Des Moines is looking to hire a transportation planner position. It has proceeded through the budget process and looks like it will make it in the upcoming city budget. The second topic was a request for an update on the Great Western Trail/Veteran's Parkway project. Current knowledge suggests that the project will not touch the existing trail or its current buffer. The new road will go north of the existing buffer and has been title E2. The City Manager Tom Hadden suggested that he would work with the business community to seed money for ongoing trail maintenance funding. Existing trail crossings may be expanded in the future, but at this time it does not seem like there will be any new crossings proposed. Concerns were raised about safety of crossings with increased street traffic. More information was not available as West Des Moines was not present for the meeting.

9. Project Updates

- The Bike Collective provided an update on state legislation around bicycling. Safe passing language remained alive in HB 130 and SB235.
- Urbandale has bids out for Colby Woods trail
- Polk County Conservation has a let date for the Ackelson Trail
- Perry is hosting an economic development conference at the end of March and will host the August 25-26 American Discovery Trail meeting
- Ames is adding four bicycles to their fleet
- Windsor Heights will have a final reading for their comprehensive plan, which includes sidewalk plan and trail hub development
