### 1. Update on the current Iowa DOT study of Interstate 80

Issue Summary:

Principal Engineer Eric Petersen presented on the Iowa DOT study for Interstate 80. The Iowa DOT is currently conducting a planning study on the Interstate 80 corridor through the state. Their stated goal is to "evaluate safety, capacity, and infrastructure deficiencies in an effort to increase mobility across the interstate system." The current study focuses on the rural sections of I-80 (west of Grand Prairie Pkwy), with urban sections of I-80 planned to be part of a future study.

Eric gave a summary of the DOT's findings and recommendations that have been released to date. Complete information, as well as a survey where the public can submit their opinions, can be found online at https://iowadot.gov/interstatestudy/home. The study is anticipated to be complete in early 2018. Mr. Petersen believes it would be beneficial to share the study with the public via Facebook and other forms of communication so that they can provide their input to the DOT.

### 2. Sidewalk Waivers – 3509 Pommel Place

### Issue Summary:

This is a follow up review of the sidewalk program for the use of concrete pavers and looking for direction on if they would be allowed. The homeowner Bryan Myers was in attendance.

The committee discussed the property located at 3509 Pommel Place and the concrete paver driveway. Policies and current specifications were discussed in regards to the sidewalk requirements. Homeowner Bryan Myers gave an up to date history of his property and the upkeep and cost of the concrete pavers on his driveway and sidewalk. He was made aware of the city's policy on sidewalks and tripping hazards.

Councilman Trevillyan discussed the use of pavers and concrete in order to maintain the six inches of thickness that is required in the specifications on drive approaches and the adjacent sidewalk. Councilman Messerschmidt requested the homeowner to notify the city of the exact thickness of his pavers. More discussions and research will need to take place on this issue and it will be brought up again in the next agenda.
