### **Director's Report:**

- Client Activity and Discretionary Review:
  - o Board reviewed the client activity and discretionary review with no concerns reported.
  - Althea shared that the Food Pantry pinto programs first month of function is complete.
    Reported to be busiest on Friday morning, which is also the time of pantry's weekly food delivery.
- Building Update:
