West Des Moines City Council Proceedings Monday, June 25, 2018

Mayor Steven K. Gaer opened the regularly scheduled meeting of the City Council of West Des Moines, Iowa, in the Council Chambers of the West Des Moines City Hall on Monday, June 25, 2018 at 5:30 PM. Council members present were: R. Hardman, J. Mickelson, J. Sandager, K. Trevillyan, and R. Trimble.

On Item 1. Agenda. It was moved by Trimble, second by Hardman approve the agenda as presented.

On Item 3. Council/Manager/Other Entities Reports:

Council member Trevillyan reported he attended the "Great American Campout" event this weekend on the City Hall campus, which offered a number of outdoor activities and received a lot of positive feedback. He requested that staff provide additional information on the event.

Sally Ortgies, Parks and Recreation Director, reported this was a first-time event, but it was well attended with approximately 80 people. She stated staff received positive feedback and is considering putting the event on again next year.

Council member Trimble reported the Finance and Administration Subcommittee met and discussed a number of items including: the proposed acquisition of the City Hall office space owned by West Des Moines Water Works, plans for multiple stormwater improvement projects near 1st Street and Grand Avenue, the proposed extension of redevelopment incentive programs in Historic West Des Moines, several proposed amendments to existing urban renewal areas, and proposed updates to the City schedule of fees and charges.

Council members Sandager and Mickelson both spoke in support of the proposed extension of the redevelopment incentive programs in Historic West Des Moines, noting they have spoken with property owners that would not have been able to redevelop their properties without the assistance of these programs.

Council member Hardman reported she attended meetings of the Development and Planning Subcommittee and the Human Rights Commission. She commended the Human Rights Commission and City Manager Tom Hadden for participating in a World Refugee Day event, and she also commended Police Captain Jim Barrett for his presentation at a meeting of the West Des Moines School District's community equity, diversity and multicultural conversation series.

On Item 9 - Other Matters

Council member Trimble stated item 6(f) Agreement for Private Development - Ballenger Real Estate, LLC was voted down by a 2-2 vote at the June 11, 2018 meeting. However, due to the fact that Council member Sandager was absent from that meeting, he would prefer to bring it back for reconsideration with the full Council present. Under Rule 30 of the City Council Procedural Rules, he requested that the item be brought back for formal reconsideration at the July 23, 2018 council meeting.

Council member Trevillyan expressed a desire that the city-owned parcels in the 200 block of 8th Street be used for Habitat for Humanity homes, which could include a volunteer build event incorporated into an existing community event.

Council member Hardman noted that Habitat for Humanity does not build garages, which are required by City Code, so that is an issue that would need to be addressed.

Clyde Evans, Director of Community and Economic Development, stated because the lots were acquired with Woodland Hills TIF funds, they must be used for affordable housing. The intention of staff is to offer the lots to a builder to construct affordable homes, and Habitat for Humanity would qualify as such a builder. He noted Council member Hardman is correct that the garage requirement is an issue that would need to be addressed if the lots would be conveyed to Habitat for Humanity.

Mayor Gaer requested that staff place this item on an upcoming agenda of the Development and Planning Subcommittee for further discussion.

The meeting was adjourned at 6:11 p.m
