On Item 1. Approval of Agenda

France moved to approve the agenda as presented. Albertson seconded. Motion carried, 8 yes.

Suckow moved to approve the minutes as presented. Welter seconded. Motion carried, 8 yes.

On Item 5A: Motion – Approval of Recommendation to City Council - Planned On-Street Bicycle Facility on South Prairie View Drive

Peterson presented a map of the trail and sharrow routes that are currently existing. After reviewing the current options, it has been determined that the best option on South Prairie View Drive is to add an onstreet bike lane in this area. Two 10 foot travel lanes and two 5 foot bike lanes would be incorporated instead of sharrows. This would be the first official bike lane in West Des Moines. Albertson questioned if the joint where the curb and gutter meets the road would be maintained differently where the bike lane will be marked. Peterson stated that Public Services would maintain these joints, and he will communicate with them about the bike lane. Welter asked about the current speed limit. Peterson stated it is 30 mph which falls within the guidelines for bike lanes. Welter questioned if there will be added signage, and Peterson stated there would be.

France moved to approve the Recommendation to City Council - Planned On-Street Bicycle Facility on South Prairie View Drive. Christiansen seconded. Motion carried, 8 yes.

On Item 5B: Update – BCycle Bike Share – Raccoon River Park

Ortgies stated that Parks and Recreation was approached by the Des Moines Bicycle Collective regarding an available BCycle bike share station. They proposed placing it in Raccoon River Park where it would function primarily as a stand-alone station. Parks and Recreation is looking at this as a pilot project to gauge interest in future bicycle rentals at the proposed Boathouse in Raccoon River Park. Since it is being located on park property, the Parks and Recreation Advisory Board is responsible for a recommendation to the City Council. The Board did approve the proposal, and the agreement will be taken to Council for approval on June 11, 2018. If approved, Ortgies stated it could potentially be installed by the end of June. The term of the agreement with the Bicycle Collective is through December 31, 2019. Suckow asked if there is a cost to the city for the station. Ortgies stated that there is no cost for the station other than Parks and Recreation covering the cost of the advertisement that is normally on the station. The Parks and Recreation Board preferred to not have any outside advertisement on the station. The advertising cost will be \$3,750 for the term of the agreement. Ortgies stated that the station will be located on existing concrete, so there is no cost related to installation.

On Item 5C: Update - Veterans Parkway Construction

Ortgies updated the Commission on the Veterans Parkway Construction and impacts to the Great Western Trail. The contractor has 10 weeks to complete the project once it is started so it is a fairly short timeframe. There are three areas of the trail that will be impacted by the construction: SE Maffitt Lake Road, SE Orilla Road, SE 35th Street. Ortgies presented the informational video that is being developed to communicate trail impacts to the public. The Commission provided feedback on suggested changes to the presentation. Ortgies presented maps illustrating the temporary and permanent routes during and after the construction. Suckow questioned if the contractor is required to post signage. Ortgies stated that signage will be posted for vehicles and pedestrians. Ortgies stated that Parks and Recreation will be working with Engineering to provide communication. Eddy suggested adding information to the Great Western Trail Facebook page.

Sadler stated that the Knolls Greenway Trail between Aspen and Crossroads Park is complete other than site restoration. Concrete trail repairs along Westown Parkway and 60th Street are complete. Rain has caused additional drainage issues on the underpasses. Sadler is working with Public Services and Engineering for alternate solutions for the underpass flooding issues. It appears to be getting worse due to additional construction and changes in land use. Marco Alvarez is working on a plan to add bike parking locations in Valley Junction and parks. Eddy stated that the drivers are speeding at Raccoon River Park. Ortgies stated we could possibly get the mobile speed trailer placed there and will contact the police department regarding this issue.

ITEM: Presentation – Windsor Heights Trail Connection

FINANCIAL IMPACT: No related expenses at this time.

SYNOPSIS: City staff, with the assistance of Bolton & Menk, have been coordinating efforts with the City of Windsor Heights to determine feasibility for a trail connection along the 8th/73rd Street corridor. The conceptual level design study has looked at multiple alignments including both on and off-street bicycle facilities, or combination of both. The study limits consist of a trail connection from the City limits at 8th Street to a planned on-street bike facility at 4th and Ashworth for an ultimate connection to the Valley Junction area.

Chadd Kahlsdorf, an engineer with Bolten & Menc, will be present to give a presentation on the study. A meeting of the Engineering Committee will be set up to review the plans in more detail.

SYNOPSIS: City staff, with the assistance of Bolton & Menk, have been looking at potential ways to provide a more direct trail connection between Raccoon River Park and Valley Junction. A conceptual level design process has reviewed a variety of proposed trail alignments connecting the existing Levee Trail along Lincoln Street to the Railroad Avenue crossing of 8th Street, then utilizing an existing wide sidewalk (box culvert) and an on-street facility along Maple Street to connect to the Valley Junction business district.

Chadd Kahlsdorf, an engineer with Bolten & Menc, will be present to give a presentation on the study. A meeting of the Engineering Committee will be set up to review the plans in more detail.

5. REPORT: LRTP Status

Staff presented on the current status of the Long Range Transportation Plan process due for adoption in fall 2019. Project solicitation and commenting will begin this fall and projects will be brought through the Roundtable for review.

Roundtable requested review of the Environmental Justice areas, scoring criteria, and new performance measures.

6. DISCUSSION: Regional Trail Gap Map

Staff presented on subcommittee work last year on updating the trail gap map for the next LRTP. In 2017, the subcommittee identified 18 gaps on level 1 and 2 trails. This list will be updated this year and then refined by staff to be included in the LRTP and project scoring criteria.

7. REPORT: Trail Counter Program Update

Staff led a discussion on the trail counter program and how the MPO will transition to a more strategic program for counter usage. At this point, the MPO expects to send out an inventory form to all agencies to determine how many MPO and other counters are in use. The MPO will also likely recall all trail counters this winter to maintain counters and transition to new placements.

9. Project Updates

 Polk County Conservation working on flood response on High Trestle Trail, especially with detour route. There may be buy-outs along Fourmile to create a greenbelt including closing some streets.

Central Iowa Bicycle-Pedestrian Roundtable

- Ankeny working on 8' sidepaths within communities and moving forward with HTT extension through town.
- Johnston at the midpoint of their walkability study. Study should result in new trails, sidewalks, and crosswalks into the CIP. Bid letting has begun on the Merle Hay Trail with construction this fall.
- DART finishing major service changes that will impact most routes. New fareboxes are being installed on buses that will allow mobile payments and provide new data.
- West Des Moines looking at reconstruction of the Levee Trail. First phase of sharrow program installed this summer.
- Clive work on greenbelt continues with installing second lift.
- Urbandale working on fixing trail washouts especially below bridge at Douglas Ave.
- Dallas County Conservation working on RRVT connection with Perry.
- Pleasant Hill cleaning trails after flooding.
- Des Moines East Douglas to Hubbell still closed. Gay Lea Wilson will require reconstruction in the near future. Pump station projects this fall will affect trails for up to a year including area around Mullets and around MLK bridge.
