West Des Moines City Council Proceedings Tuesday, September 4, 2018

Mayor Steven K. Gaer opened the regularly scheduled meeting of the City Council of West Des Moines, Iowa, in the Council Chambers of the West Des Moines City Hall on Tuesday, September 4, 2018 at 5:30 PM. Council members present were: R. Hardman, J. Mickelson, J. Sandager, K. Trevillyan, and R. Trimble.

On Item 1. Agenda. It was moved by Trimble, second by Trevillyan approve the agenda as presented.

On Item 2. Public Forum

Ed Ames, 308 6<sup>th</sup> Street, expressed concerns that the City enforces its right-of-way ordinances inconsistently, as the City removed a mailbox he placed in the right-of-way in front of his home, yet other violations occur in the right-of-way without consequence.

Jim Miller, Executive Director of the Historic Valley Junction Foundation, reported the cover story in the latest issue of the Iowa History Journal is about James Jordan and the book about him that will be released in the coming weeks. He noted some funding for the book was provided by the City as part of WDM125, and he thanked the Mayor and Council for their support.

Council member Sandager reported he spoke on behalf of the City at an event for the West Des Moines Historical Society's Jordan Scholars program.

Council member Trimble reported he spoke on behalf of the City at a ribbon cutting ceremony for the Phenix School Apartments.

Council member Mickelson reported he attended a meeting of the West Des Moines Chamber of Commerce board, which had invited candidates for state and local office to speak. He also noted City Manager Tom Hadden will be speaking at an upcoming meeting about the City's comprehensive plan update.

She also attended a Library Board of Trustees meeting, where an update was given on the library's ongoing construction projects. President/CEO of the West Des Moines Chamber of Commerce, regarding diversity issues and potential initiatives.

It was moved by Trevillyan, second by Trimble to waive the third reading and adopt the ordinance in final form.

On Item 6(a) Mayor Gaer indicated this was the time and place for a public hearing to consider Amendment to City Code - Title 9 (Zoning), Chapter 15 (Off-Street Parking and Loading) - Modify Regulations for Individual Residential Driveways, initiated by the City of West Des Moines. He asked for the date the notice was published and the City Clerk indicated the notice

was published on August 17, 2018 in the Des Moines Register. Mayor Gaer asked if any written comments had been received. The City Clerk stated on a vote of 6-0, with one member absent, the Plan and Zoning Commission recommended City Council approval of the ordinance amendment.

Lynne Twedt, Development Services Director, reported both staff and the Plan and Zoning Commission recommend the option to allow driveway stalls with an angled flare. The concerns about the straight driveway design were that it could potentially lead to tire ruts in the grass right-of-way from vehicles cutting through and more breakages in the sidewalk from vehicles travelling over the concrete that isn't reinforced.

Council member Mickelson noted another concern he has about the straight-edge flare is that pedestrians may not be anticipating vehicles driving near the sidewalk that is not within the width of the driveway approach.

Mayor Gaer asked if there were any public comments.

Ed Ames, 308 6<sup>th</sup> Street, stated he doesn't have a preference between driveway stalls with an angled flare or straight, but he believes the driveway approach should be as wide as the driveway. He also noted he believes the City should consider restricting parking within the driveway approach between the street and the sidewalk.

Mayor Gaer asked if there were any additional public comments; hearing none he declared the public hearing closed.

Council member Trevillyan expressed support for the straight-edge option, as he believes it would be the more suitable option for backing up a trailer without running over the grass.

Council member Trimble expressed support for the angled flare option, because it would be a smaller paved surface and he thinks it looks better.

Council member Sandager expressed support for the straight-edge option, as he believes it would be easier for beginning drivers to navigate their vehicle into the stall without driving off the paved surface and potentially creating tire ruts in the grass.

It was moved by Mickelson, second by Trimble to consider the first reading of the ordinance, with the angled flare option as depicted in Attachment C of the council communication.
