### **Approval of Minutes:**

#### **Director's Report:**

- Check were made payable to fundraiser as "West Des Human Services" rather than including "Friends Foundation" (recap of available funds report, trust account)
  - We are unable to transfer these funds as titled
  - Friends Foundation donated a walk-in cooler to accommodate and preserve the additional produce we are receiving due to the Food Pantry pilot project.
  - There is no requirement of City approval for funds use, the Friends Foundation board receives requests and makes approval or denial decision prior to use.
  - RRCAP Red Rock Community Action new name is IMPACT we are subcontractor for federal funding for LIHEAP receiving \$1,000.00 per month to process applications
- Board expressed concerns with the transportation review:
  - No timeframe provided
  - Approval has been received to hire additional part time drivers. Currently limited drivers on staff, we are unable to move forward in hiring until further determination of program.
  - o Transportation hours available through DART VS West Des Moines Human Services
  - Accident reports for DART vs West Des Moines Human Services
- Safety concerns with city area:
  - Currently reviewing front desk options, with additional visibility to building access
  - o Reviewing a panic button option to lock building doors automatically
    - Currently the receptionist desk has a silent panic alarm button, alerting 911.
    - Currently has a bell available and viewing area to exterior
  - Back door currently remains locked during business hours.
  - Recommendation for one entry way and bullet proof glass around the receptionist area.

- Mentally III Awareness was proposed to coach other city building employees to speak with and work with mentally ill individuals.
- Journeymen group currently has approximately 24 homes on the list for home repair needs.
  - Meeting scheduled on 6-20-18 to discuss client scheduling
- Council Member Russ Trimble recognized the impact of the community outreach by Carmen Murillo as she served as the transportation director.
- Volunteer Reports indicate an increase in volunteerism.
- Althea thanked the board for organizing the staff appreciation lunch. Thank you letter received and shared with board
