West Des Moines City Council Proceedings Monday, November 12, 2018

Mayor Pro Tem Jim Sandager opened the regularly scheduled meeting of the City Council of West Des Moines, Iowa, in the Council Chambers of the West Des Moines City Hall on Monday, November 12, 2018 at 5:30 PM. Council members present were: R. Hardman, J. Mickelson, J. Sandager, K. Trevillyan, and R. Trimble.

City Clerk Ryan Jacobson stated there is one amendment to the agenda, as the workshop regarding the amphitheater project is being cancelled.

On Item 1. Agenda. It was moved by Trimble, second by Trevillyan approve the agenda as amended.

On Item 2. Public Forum

Ray Perez, 620 11<sup>th</sup> Street, spoke in opposition to the City's animal control ordinance, which has a limit of four pets per household, because he currently has approximately 70 show pigeons.

The City Council requested that staff review the animal control ordinance and respond to Mr. Perez.

On Item 3. Council/Manager/Other Entities Reports:

Bret Hodne, Public Services Director, recognized Eric Goode and Jon Keimig, as their team won 1<sup>st</sup> place in the truck competition at the 2018 Snow Plow Roadeo.

Council member Trevillyan noted today is Veterans Day, and he expressed appreciation to his fellow military brothers and sisters that have served or are currently serving in the military.

Council member Trimble also expressed appreciation to the veterans, and he thanked the Parks and Recreation department for releasing content promoting the folded flags artwork that will be installed along Veterans Parkway. He also reported the Des Moines Area Regional Transit Authority (DART) Commission met and discussed potential funding options, such as seeking legislation to allow additional types of tax levies and seeking a 50-cent increase in the levy cap.

Council member Hardman also expressed appreciation to the veterans, and she reported she attended several Veterans Day celebrations.

It was moved by Trimble, second by Hardman to approve the second reading of the ordinance.

It was moved by Trimble, second by Hardman to waive the third reading and adopt the ordinance in final form.

Vote 18-606: Hardman, Mickelson, Sandager, Trevillyan, Trimble...5 yes Motion carried.

On Item 5(b) Redevelopment Funding Programs in Historic West Des Moines, initiated by the City of West Des Moines (Continued from October 29, 2018)

It was moved by Trimble, second by Sandager to adopt Motion - Approval of Subcommittee Recommendation.

Council member Trimble stated he believes the proposed amendment to the program's eligibility requirements makes sense, as it would allow both landlords and tenants to receive funding for different projects within the same building.

Council member Trevillyan expressed opposition to the proposed amendment, because the second year of the program is almost complete, and this change was not even brought up until two weeks ago. He noted it would not be fair to other potential applicants that would become eligible through this amendment but were not eligible to apply previously and did not think to request a change in the eligibility requirements. He also noted the application that initiated this

amendment was submitted on October 25<sup>th</sup>, but he believes it should not have been accepted by staff because it was not even eligible at the time.

Council member Mickelson stated he believed the intention for this program was to provide incentives to property owners but not tenants, therefore he does not support the proposed amendment.

Council member Trimble stated he believes the program has already awarded funding to tenants for projects done in conjunction with the property owner.

Clyde Evans, Community and Economic Development Director, confirmed several tenants have applied for and received funding from these programs, but those applications required signatures from the property owner as well.

Mr. Evans requested clarification that the Council's motion to approve the amendment is also intended to allow the application that initiated this amendment to become eligible to proceed through the review process.

Mayor Pro tem Sandager confirmed the application should become eligible to proceed.

On Item 6(a) Mayor Pro Tem Sandager indicated this was the time and place for a public hearing to consider Bridgewood, northwest corner of Jordan Creek Parkway and Bridgewood Boulevard - Amend Planned Unit Development (PUD) to Allow Monument Signs on Parcel M to Include Any Business within Bridgewood Square Regardless of Property Lines, initiated by Bridgewood Commercial, LLC.
