#### 6. HR MEI Report- Jane Pauba-Dodge

• HR director Jane Pauba-Dodge presented the City's Municipal Equality Index score from the Human Rights Campaign. The commission asked questions and gave suggestions on the different sections of the scorecard. The City's score improved from a 79 in 2017, to a 93 out of a 100 for 2018. Human Rights Commission Chair Sanjita Pradhan thanked Jane for the presentation and stated that these are starting points for real change in the community and these things take time and the commission is excited to start this journey with the City.
