West Des Moines City Council Proceedings Monday, March 4, 2019

Mayor Steven K. Gaer opened the regularly scheduled meeting of the City Council of West Des Moines, Iowa, in the Council Chambers of the West Des Moines City Hall on Monday, March 4, 2019 at 5:30 PM. Council members present were: R. Hardman, K. Trevillyan, and R. Trimble. Council member J. Sandager participated via telephone.

City Clerk Ryan Jacobson stated Item 4(c)9 Renewal of Liquor License - Wine Experience at Younkers Jordan Creek has been removed from the agenda, because the applicant has withdrawn their application.

On Item 1. Agenda. It was moved by Hardman, second by Trevillyan approve the agenda as amended.

On Item 6(a) Mayor Gaer indicated this was the time and place for a public hearing to consider Amendment to City Code - Title 9 (Zoning), Chapter 1 (Entitlements - Process and Procedures), Chapter 2 (Zoning Rules and Definitions), Chapter 4 (Zoning Districts and Maps), Chapter 5 (Agricultural/Open Space and Residential Zoning District), Chapter 7 (Setback and Bulk Density Regulations), Chapter 10 (Performance Standards), and Chapter 19 (Landscaping) - Update Regulations Pertaining to Building Setback and Separation Requirements and Bulk Density Regulations, initiated by the City of West Des Moines (Continued from February 4, 2019). He asked for the date the notice was published and the City Clerk indicated the notice was published on January 18, 2019 in the Des Moines Register. Mayor Gaer asked if any written comments had been received. The City Clerk stated on a vote of 6-0, with one member absent, the Plan and Zoning Commission recommended City Council approval of the ordinance amendment.

Linda Schemmel, Development Coordinator, presented an overview of the proposed changes to the City Code, and more specifically, one which would add footprint lots as a subdivision regime in single family zoning districts. This would offer a new option for developers to cluster detached townhomes closer together, while still maintaining existing setback requirements with the surrounding properties, which could be particularly beneficial when developing new areas of the city where the terrain is more challenging.

Council member Trimble expressed concerns that single family residents might not support these footprint lots being developed adjacent to their properties.

Ms. Schemmel noted the proposed ordinance would require developers to go through the site plan and platting processes. It would also require the homes to be no less than 75 percent and no more than 150 percent of the average home size in the area. She also presented information on the architectural performance standards in the proposed ordinance.

Mayor Gaer inquired if staff has discussed these proposed City Code changes with developers.

Ms. Schemmel responded they have not, but staff did reach out to the neighboring communities for information on their architectural standards and was able to provide an overview of each community's requirements.

Mayor Gaer asked if there were any public comments; hearing none he declared the public hearing closed.

The Mayor and Council expressed a desire that this proposed ordinance be continued to allow time for staff to share it with developers so they can review it and provide feedback.

It was moved by Trevillyan, second by Trimble to continue Item 6(a) Amendment to City Code - Update Regulations Pertaining to Building Setback and Separation Requirements and Bulk Density Regulations to April 1, 2019.

Council member Trimble inquired why a HAWK beacon is being installed at this intersection, before one is installed at the intersection of 39th Street and EP True Parkway.

Brian Hemesath, City Engineer, responded as part of this project, staff conducted traffic counts for both vehicles and pedestrians at this intersection. It was determined the intersection met the warrants for a HAWK beacon, and this widening project would be the ideal time to have it

installed. He noted staff is currently working on traffic counts for the intersection of 39th Street and EP True Parkway to determine if it will meet warrants for a HAWK beacon as well.

On Item 9(a) Legislative Updates

Jamie Letzring, Deputy City Manager, stated the first funnel date is March 8th, and she reported on the following bills:

- HF 542 / SSB 1221 regarding the acquisition of land by governmental entities: This bill would restrict funding options that the City has historically used to acquire park land. The City's lobbyists have reported that the bill will not move forward in its current form, and

if it does move forward it is expected to remove the restriction for cities. Staff will continue to monitor this bill.

- SF 368 / HSB 100 regarding lawful preexisting non-comforming ordinances: This bill would prohibit cities from adopting ordinances that infringes on a property owner's non-conforming use unless that use poses a threat or is abandoned. Staff has some concerns with this bill. The City is registered as undecided and is seeking to offer input.
- SSB 1152 / HSB 32 regarding fees for use of right-of-way: This bill would place limitations on what utility companies would have to pay municipalities for the use of their right-of-way. Staff does not believe this bill would create issues for the City of West Des Moines, so the City is currently not registered.

Ms. Letzring also reported there is pending legislation regarding cities' rights to establish stormwater fee districts. The bill is currently with the local government subcommittee.
