# CITY OF WEST DES MOINES CITY COUNCIL MEETING COMMUNICATION

**DATE:** May 9, 2019

ITEM: Resolution – Award Contract – Neighborhood Park Signage

**FINANCIAL IMPACT:** Total contract amount of \$249,964.00. There is a total budget of \$450,000 available for this project. The project will be paid with budgeted CIP funds from G/L account 500.000.000.5250.490. Funding will be covered out of available funds in the FY 18-19 and FY 19-20 CIP from the Park Signage Upgrade (Project No. 0510 094 2017).

BACKGROUND: Eight (8) bids were received, with several bids under the preliminary estimated cost of \$447,150. The lowest base bid in the amount of \$248,421.00 was submitted by Hilton Displays, LLC from Greenville, South Carolina. The next lowest bid in the amount of \$249,964.00 was submitted by Nagle Signs, Inc. from Waterloo, Iowa. Nagle Signs submitted a request that their bid receive a resident-bid preference. Legal staff reviewed the request, and by applying the *Reciprocal Resident Bidder and Labor Force Preference* as required by Iowa statue resulted in an adjusted bid, which made the Nagle Sign, Inc bid the low bid. Staff therefore recommends awarding the contract to Nagle Signs of Waterloo, Iowa. Nagle Signs has completed a wide variety of projects for metro communities including City of Urbandale (Gateway signs), City of Des Moines (Central Iowa Trail System Info Panels), and City of Ankeny (Market Pavilion). In addition, Nagle Signs is currently manufacturing the Folded Flags public art pieces for the Veteran's Parkway Enhancements project, and staff has been pleased with this process.

This resolution is for the initial phase of construction for the replacement of neighborhood park signs located throughout the park system. The current wooden signs within the City's neighborhood parks are over 20 years old with many showing signs of decay and age. The replacement signs are designed in the same family as other signs throughout the City, and will be constructed of a combination of corten steel, sandblasted aluminum, and stainless steel lettering, all mounted on a concrete footing.

**OUTSTANDING ISSUES:** None.

**RECOMMENDATION:** That the Council pass the resolution to award the contract for the Neighborhood Park Signage in the amount of \$249,964.

### CITY OF WEST DES MOINES OFFICE OF THE CITY ATTORNEY LEGAL OPINION

Re: Neighborhood Park Signage Project- Resident Vendor Preference

Date: May 7, 2019

On April 10, 2019 the City of West Des Moines received bids from eight bidders for the fabrication and installation of twenty-five neighborhood park identification signs. Hilton Displays, LLC of Greenville, South Carolina submitted the low bid of \$248,421.00. Nagle Signs, Inc., of Waterloo, Iowa submitted the second lowest bid of \$249,964.00. As set forth in Iowa Code Chapter 73A.21, *Reciprocal Resident Bidder and Labor Force Preference*, Nagle Signs submitted a request with its bid that if relevant, it's bid receive a resident-bid preference.

The Iowa statute requires that the City of West Des Moines provide a preference to an Iowa bidder as against a non-Iowa bidder if the non-Iowa bidder is from a state that gives any form of preferential treatment to bidders from that state. <u>Iowa Code</u> 73A.21(2). The preference allowed must be equal to the preference given or required by the state in which the non-resident bidder is a resident. <u>Id.</u>

South Carolina Code 11-35-1524, Resident Vendor Preference gives preferential treatment to public contracts in which South Carolina labor or products are used. The South Carolina statute provides a preference for both the "End Product<sup>1</sup>", which would be the signs described in the bid solicitation and fabricated for use by the City, and a preference for the use of resident labor. Therefore, as required by the Iowa statute, the terms of the South Carolina Vendor Preference must be applied to the Nagle Signs bid.

Although the South Carolina statute provides a preference for the use of resident labor, because Hilton Displays, LLC has indicated that it would contract for an Iowa subcontractor to perform the labor, no residential labor preference to the Nagel Sign, Inc. bid is required.

However, the South Carolina Vendor Preference also provides a seven percent price decrease of any South Carolina resident bid for use of a South Carolina End

Product. South Carolina Code 11-35-1524(B)(1).

Giving equal preference of seven percent to the Iowa-resident bid of Nagle Signs for use of an Iowa End Product comprising the fabrication of twenty-five signs, and assuming that the End Product constitutes at a minimum fifty percent of the total bid price, a reduction of \$8,748.00 (\$249,964.00 x 50% x 7%) of the Nagel Sign bid price is required.

Therefore, although the bid of Hilton Displays, LLC was \$1,543.00 less than the bid of Nagle Signs, Inc., applying the *Reciprocal Resident Bidder and Labor Force Preference* as required by Iowa statute results in an adjusted Nagel Sign, Inc. bid of \$241,216.00, making the Nagel Sign, Inc. bid the low bid.<sup>2</sup>

**WHEREAS**, the City Council of the City of West Des Moines has heretofore directed advertisement for bids for the following described public improvement:

and

WHEREAS, bids have been received and opened by the City Clerk, Deputy City Clerk, or designee and placed on file by the City Council; and

**WHEREAS**, Hilton Displays, LLC from Greenville, South Carolina submitted the low bid in the amount of \$248,421.00 for the public improvement; and

WHEREAS, application of <u>Iowa Code</u> 73A.21, *Reciprocal Resident Bidder and Labor Force Preference* reduced the bid of Nagle Signs, Inc. of Waterloo, Iowa, the second lowest bidder, from \$249,964.00 to \$241,216.00 for purposes of bid comparison and award; and

**WHEREAS**, upon application of Iowa Code 73A.21, Nagle Signs, Inc. has submitted the lowest responsible bid for the public improvement project.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WEST DES MOINES, IOWA, THAT:

- 1. Pursuant to <u>Iowa Code</u> 73A, *Reciprocal Resident Bidder and Labor Force Preference*, the adjusted bid submitted by Nagle Signs, Inc. in the amount of \$241,216.00 is the lowest responsible bid for the Neighborhood Park Signage Project, Project No. 510-094-2017.
- 2. Pursuant to <u>Iowa Code</u> 73A, the contract is hereby awarded to Nagle Signs, Inc. in the amount of \$249,964.00 and the bond of said bidder for the Project is hereby fixed in the same amount.
- 3. The Director of Parks and Recreation is authorized and directed to return bid bonds and/or checks to any unsuccessful bidder.
- 4. Work on the Project may commence as soon as the final contract and bond have been approved by the Director of Parks and Recreation and have been signed by the Director of Finance, and after written notice is given to the contractor to proceed by the Director of Parks and Recreation.






