West Des Moines City Council Proceedings  
Monday, August 19, 2019

Mayor Steven K. Gaer opened the regularly scheduled meeting of the City Council of West Des Moines, Iowa, in the Council Chambers of the West Des Moines City Hall on Monday, August 19, 2019 at 5:30 PM. Council members present were: R. Hardman, J. Mickelson, J. Sandager, K. Trevillyan, and R. Trimble.

On Item 1. Agenda. It was moved by Trevillyan, second by Trimble approve the agenda as presented.

Members of the Gnemeth Masonic Lodge presented a donation to the West Des Moines Police Department for a K9 officer vest.

Council member Trevillyan reported he will hold a Ward 1 quarterly town hall meeting on Saturday, August 31<sup>st</sup>.

Council member Trimble reported the Des Moines Area Regional Transit Authority (DART) is discussing adding different modes of transportation to its service delivery and potential changes to its funding formula.

Council member Hardman reported the Taste of the Junction Multicultural Festival will be held on Saturday, August 31<sup>st</sup> in Railroad Park. She also reported she attended a meeting of the Development and Planning Subcommittee, where discussion was held on potential changes to the sign ordinance.

City Manager Tom Hadden reported he attended a meeting of the West Des Moines Water Works Board of Trustees, where discussion continued on regionalization.

Mayor Gaer reported he swore in two new police officers and a new chaplain at the Law Enforcement Center on Friday, August 16<sup>th</sup>.

On Item 4(f) Approval of Special Event Lane Closure and Waiver of City Code Requirement - Taste of the Junction Multicultural Festival, August 31, 2019

William Gary LaFollette, 415 Railroad Place, stated he does not object to the events, however the Saturday events in August and September that close Railroad Place are having a negative impact on his business. He suggested that those events consider other locations in future years.

August 19, 2019

Mayor Gaer noted event organizers are attracted to Railroad Place because of the Railroad Park pavilion and the public restrooms. He inquired if Mr. LaFollette would agree to allow the events already scheduled for 2019 be held on Railroad Place, and then the event locations could be reviewed for 2020.

Mr. LaFollette agreed with Mayor Gaer's suggestion.

Shirlee LaFollette stated she sent a similar letter last year expressing opposition to the events on Railroad Place, but their concerns were never addressed.

Mayor Gaer requested that staff work with event organizers for the events that close Railroad Place to consider other locations for 2020.

Council member Trimble expressed appreciation to staff for making progress on this HAWK beacon project, as he believes it will help address a safety concern at this intersection.

On Item 4(t) Approval of Policy for Inspection and Enforcement of Storm Water Pollution Prevention Activities

Council member Trimble expressed concerns that if there is no fee for a first re-inspection, then the fees might not cover the costs, which would shift the burden onto the general taxpayer.

Brian Hemesath, City Engineer, reported staff determined it would be appropriate to conduct a first re-inspection with no fee, because such inspections are routine and staff did not want to penalize developers when they've promptly corrected an issue. He noted cases with two or more re-inspections consume significant staff time, so the proposed fees escalate with each subsequent re-inspection.

August 19, 2019

Mayor Gaer noted the second re-inspection fee is \$500, which is high compared to other metro cities. He also noted the policy authorizes staff to impose a stop-work order on a site if deemed necessary.

It was moved by Trimble, second by Sandager to approve Item 4(t) Approval of Policy for Inspection and Enforcement of Storm Water Pollution Prevention Activities.

Council member Mickelson reported the City Campus Amphitheater project was one of the potential “game changer” projects that were first considered several years ago. He noted this donation from the Hurd family will bring that project one step closer to a reality, and he expressed appreciation to the Hurd family for their generosity.

Richard Hurd, 2000 Fuller Road, expressed appreciation to the City for the opportunity to work together on moving this project forward, and he stated he looks forward to the amphitheater opening and hosting events that will be enjoyed by the community for many years.

Council member Sandager stated he is passionate about the arts, so he is very excited about this project, and he expressed appreciation to the Hurd family for their generosity.

Mayor Gaer asked if any written comments had been received. The City Clerk stated none had been received.

Mayor Gaer asked if there were any public comments; hearing none he declared the public hearing closed.
