West Des Moines City Council Proceedings
Tuesday, September 3, 2019

Mayor Steven K. Gaer opened the regularly scheduled meeting of the City Council of West Des Moines, Iowa, in the Council Chambers of the West Des Moines City Hall on Tuesday, September 3, 2019 at 5:30 PM. Council members present were: J. Mickelson, J. Sandager, K. Trevillyan, and R. Trimble. Council member R. Hardman participated via telephone.

It was moved by Trimble, second by Trevillyan to adopt Resolution - Approval of Plans and Specifications, Motion to Receive and File Report of Bids, and Resolution - Award Contract to Henkel Construction.

Mayor Gaer noted the amphitheater project was first talked about approximately 12 years ago, so there has been a lot of excitement in the community for this project. He also expressed appreciation for the private donations from Microsoft Corporation and the Hurd family, which helped make this project possible.

The Council members also expressed excitement for this project and appreciation to the private donors.

On Item 7(c) Williams Property, 34097 V Place - Plat of Survey for Transfer of Ownership, initiated by Old Post Properties, LLC

Mayor Gaer noted there is one outstanding issue regarding the Irrevocable Offer of Right of Way Dedication, and he requested clarification for why this is calling for the applicant to dedicate 27 additional feet of right-of-way since it is being developed for one single-family house.

City Attorney Dick Scieszinski reported there is already an existing 33-foot right-of-way easement, but since the applicant is splitting the property with this plat-of-survey, staff is requesting the applicant dedicate an additional 27 feet to meet the right-of-way requirements in the comprehensive plan. He noted the property may never be formally subdivided, so the City might not get another opportunity to bring the plat into compliance with the comprehensive plan.

Mayor Gaer expressed opposition to the requirement for 27 additional feet of right-of-way, and he noted if the City wishes to widen the street in the future, it could purchase the additional right-of-way from the property owner at the time it is needed.

City Attorney Scieszinski noted if the Council does not wish to require the 27 additional feet of right-of-way, he recommends the City still require the existing 33-foot right-of-way easement be dedicated to the City in fee title.

The Mayor and Council held further discussion on the appropriate amount of right-of-way that should be required in this case, and the Council reached a consensus that no additional right-of-way should be required but the 33-foot right-of-way easement should be dedicated to the City in fee title.

It was moved by Trevillyan, second by Trimble to adopt Resolution - Approval and Release of Plat of Survey, subject to the applicant complying with all applicable City Code requirements and the amended conditions of approval listed in the Resolution.
