West Des Moines City Council Proceedings Monday, May 4, 2020

Due to the State Public Health Emergency Declaration regarding COVID-19, this meeting was conducted electronically pursuant to Iowa Code 21.8 and the Proclamation of Governor Kim Reynolds dated March 19, 2020.

Mayor Steven K. Gaer opened the regularly scheduled meeting of the City Council of West Des Moines, Iowa, via teleconference on Monday, May 4, 2020 at 5:30 PM. Council members present via teleconference were: R. Hardman, G. Hudson, M. McKinney, K. Trevillyan, and R. Trimble.

On Item 1. Agenda. It was moved by Trimble, second by Hardman approve the agenda as presented.

Vote 20-150: Hardman, Hudson, McKinney, Trevillyan, Trimble...5 yes Motion carried.

On Item 2. Public Forum: No one came forward.

On Item 3. Council/Manager/Other Entities Reports:

Council member Hardman noted this week is Municipal Clerks Week, and she expressed appreciation to the City Clerk's Office staff for all the work they do.

Council member McKinney expressed appreciation to Mayor Gaer and staff for extending the relief on sign code regulations for businesses in West Des Moines. He also reported he attended a meeting of the Development and Planning Subcommittee, where information was presented on methods for supporting local businesses. He also noted this week is Public Service Recognition Week, and he expressed appreciation to all City staff for the work they do.

Council member Hudson stated he is impressed with how the community has come together during this pandemic situation. He also reported the Waukee Community School District recently approved a new map for the school boundaries, and he expressed appreciation to the district for approving the option that he considers to be in the best interest of West Des Moines families.

Council member Trimble reported the Disaster Recovery Partnership Planning Advisory Committee met and discussed what the recovery from this pandemic situation should look like and how the basic needs of the community should be met going forward. He also reported he attended a meeting of the Finance and Administration Subcommittee, where discussion was held on the allocation of incoming Community Development Block Grant (CDBG) funds and how to address the budget issues of the Historic Valley Junction Foundation. He also expressed

appreciation to the Finance Department for their efforts in forecasting the City's projected budget shortfall due to the economic downturn and developing an action plan to address it.

City Manager Tom Hadden reported a cardboard box recycling drop-off station will be temporarily located in the parking lot of Valley Southwoods Freshman High School for public use in the near future. He noted permanent drop-off stations will eventually be located at the City's two Public Services facilities.

Mayor Gaer reported he has been asked to participate in an interview with Channel 5 news tomorrow morning regarding the City's response to the pandemic situation.

On Item 4(p) Approval of Termination of Lease Agreement with the West Des Moines Business Incubator - 318 5th Street

Council member Trevillyan requested clarification on the proposed termination date.

City Attorney Dick Scieszinski responded the proposed resolution would terminate the lease 180 days from the date proclaimed by Governor Kim Reynolds allowing the first phase of reopening businesses in Polk County, or June 30, 2021, whichever comes first.

Council member Trevillyan expressed concerns that if the first phase of reopening does not occur prior to January 1, 2021, then the lease would not terminate until the date it was originally set to expire anyway. He suggested the resolution should identify a specific termination date. He also expressed concerns that the sublease with Gravitate is in violation of the City's lease with the West Des Moines Business Incubator. He stated the sublease was signed by Geoff Wood, identified as owner of Welch Avenue, LLC, however he noted the Secretary of State filing lists Hope Wood as owner of Welch Avenue, LLC. He also expressed concerns that Gravitate received a payroll protection plan loan but is still collecting rent from its tenants.

It was moved by Trevillyan to approve Item 4(p) Approval of Termination of Lease Agreement with the West Des Moines Business Incubator - 318 5th Street with an amendment to specify the termination date as October 31, 2020. Motion died for lack of second.

Mr. Scieszinski stated the Public Safety Subcommittee recommended the notice of termination be counted as 180 days from the first phase of reopening for Polk County in order to allow for a transition period.

The Council members held additional discussion on the appropriate timeline for the termination of the lease, with a majority expressing support for the recommendation made by the Public Safety Subcommittee, which was intended to be a compromise that would end the relationship with the West Des Moines Business Incubator yet doing so in a reasonable manner.

It was moved by Hardman, second by Trimble to approve Item 4(p) Approval of Termination of Lease Agreement with the West Des Moines Business Incubator - 318 5th Street.

Council member Trimble stated he is sad to see this relationship come to an end, and he expressed a desire that the City continue to support small businesses in the community. He suggested establishing a small business center that could provide information and resources to owners of small businesses.

Council member Trevillyan stated, even though he doesn't fully support the wording of the termination date in the proposed resolution, he will vote in favor of this motion.

He asked for the date the notice was published and the City Clerk indicated the notice was published on April 24, 2020 in the Des Moines Register. Mayor Gaer asked if any written comments had been received. The City Clerk stated none had been received.

Mayor Gaer asked if there were any public comments; hearing none he declared the public hearing closed.

It was moved by Trimble, second by Hudson to adopt Resolution - Approval of Community Development Block Grant Program Plans.

Council member McKinney expressed a desire for the administration costs of the programs be minimized as much as possible.

Tim Stiles, Finance Director, noted the administration costs indicated on this item are truly direct program costs, such as case workers' salaries.

Council member Hardman requested additional information on the Citizen Participation Plan and the Outreach Policy for Minority and Women Owned Businesses.

Christine Gordon, Housing Planner, responded the Citizen Participation Plan is changing significantly due to the pandemic situation, as the 30-day comment period has been reduced to five days. She noted the Outreach Policy for Minority and Women Owned Businesses is reviewed and approved every five years, but there are no proposed changes at this time. She stated if the Council would like to see any changes made to that policy, staff would receive their suggestions and could make changes at any time.

On Item 6(b) Mayor Gaer indicated this was the time and place for a public hearing to consider Valley Junction Business District Pavers and Sidewalk, Phase 1, initiated by the City of West Des Moines. He asked for the date the notice was published and the City Clerk indicated the notice was published on April 24, 2020 in the Des Moines Register. Mayor Gaer asked if any written comments had been received. The City Clerk stated none had been received.

Mayor Gaer asked if there were any public comments; hearing none he declared the public hearing closed.

Mayor Gaer noted a resident had reached out to him and requested that the City save as many of the existing trees along this sidewalk as possible.

Council member Trevillyan stated he had spoken with the same resident and explained the reasons for the tree removal. He noted the resident was not happy but understood the City's position.

It was moved by Trevillyan, second by Trimble to adopt Resolution - Approval of Plans and Specifications, Motion to Receive and File Report of Bids, and Resolution - Award Contract to Minturn, Inc.

Council member McKinney commended staff for their efforts in consulting with various parties in advance of this project.

Matt Hauge, Executive Director for the Historic Valley Junction Foundation, expressed appreciation to the City for prioritizing this project and for reaching out to his organization and many of the Valley Junction businesses regarding this project.

Council member Hudson inquired if staff believes there will be sufficient parking in this area with the anticipated increase in demand from Dave & Busters going in.

Lynne Twedt, Development Services Director, responded there is ample parking in the Jordan Creek Town Center area.
