Sadler stated he walked the Sugar Creek Trail alignment with the contractor. The Levee Trail renovations should start in April. Eddy questioned the status of the traffic signal on Grand Avenue at Raccoon River Park. Sadler stated that he does not have an update, but would find an answer. Moore stated that the railroad culvert near Jordan Creek Trail, east of Prairie View Drive is eroding and the railroad should be contacted.

France questioned the progress of reducing flooding in the underpass on 50th Street. Sadler stated that waterproofing is being done to address issues with standing water. A contractor has also worked on clearing the drainage pipes. Moore questioned the increase of ice in the underpass under Mills Civic Parkway. Ortgies stated a contractor was also doing maintenance on that underpass so it is possible there was an issue with drain lines at this location as well. Ortgies stated that the lights are now working in the Great Western Trail underpass. The Parks and Recreation Department will be working with the Great Outdoors Foundation on a capital campaign for the bridge over the Raccoon River. The goal is to raise approximately \$2 million for the project. The Parks and Recreation Department is providing a \$500 sponsorship for Bike Month. The Mayor's Bike Ride is May 16. Chris Cakes will serve pancakes at a pancake breakfast prior to the bike ride for a fee. The bike ride is free this year. Eddy, Suckow, and Freund offered to help with the event.

5. PRESENTATION: City of Des Moines Levee Alterations, Steve Naber and Craig M. Bouska

The City of Des Moines will be implementing a series of bridge replacement/ rehabilitation projects and levee alterations in the future as part of a flood mitigation program. Some of these projects will impact trails. Several improvements and enhancements are being made as well including the Simon Estes Amphitheater Floodwall Improvements. Steve and Craig from the City of Des Moines provided the Roundtable members a detailed overview of each of the projects.

6. DISCUSSION: MPO Updates

MPO staff provided the following updates:

- Illustrative project list, an appendix to the Long Range Transportation Plan (LRTP) projects is up for public comment and review. The list includes a few trail projects.
- The draft Transportation Improvement Program (TIP) is up for review and comment. The TIP includes all federally funded transportation projects within the Des Moines metro for the next four fiscal years.
- MPO begins trail condition data collection next month with help from the City of West Des Moines and the Iowa Natural Heritage Foundation.

7. DISCUSSION: Trail Usage Post Covid contd.

Roundtable members have been discussing the challenges and opportunities that the Covid pandemic has brought in rethinking design of cities, trails and other facilities, as well as use. Trails continue to experience heavy usage with plenty of new users who are discovering the trails as a new way to recreate and travel while social distancing. Trail etiquette and social continues to be an issue. New riders and those riding with children sometimes pose challenges. There is an increased need for education and guidance in safe trail usage. Some restrooms along the trails have opened up.

8. Other Non-Action Items of Interest to the Committee

2020 Trail condition data collection cycle – The MPO will begin trail condition data collection
utilizing the Data Bike for 2020 in late July/August. The plan is to alternate between regional
and local data every year moving forward. This year the MPO expects to collect roughly 300
miles of local trails within the region. The MPO is partnering with INHF this year to collect
the data.

9. Project Updates

- Des Moines Parks and Rec Witmer Park loop trail, project closeout is at the end of this
 week and should be open to the public starting next week.
- City of West Des Moines Levy Trail Overlay project is substantially complete with a walkthrough scheduled tomorrow and should all be done by the end of the month. Mindy and her team is working on wrapping up the Sugar Creek Greenway Trail Phase I and hope to order construction in July with that happening from Fall to Spring 2021.
- Polk County Conservation Update on the Trestle to Trestle Bridge, currently getting through Army Corp permits, expected to go out to bid in July, however FEMA has denied full replacement cost for the bridge, expected to appeal that decision but in the meantime trying to identify other funding sources.
- Jasper County Economic Development Opening of the Phase I of the Red Rock Prairie Trail slightly delayed, some additional historical and cultural documentation along trail is being required by IDOT, probably not go out to bid this year, but looking at some additional grants so the entire stretch between Monroe and Mitchellville can be built together next year which would only leave about a 1.5 mile gap to link to the CVT and about a little ober 3 miles to Altoona.
- Estimate for the Trestle to Trestle is about \$1.5 to \$1.7 million.

Trail, Preliminary Design

FINANCIAL IMPACT: Expense of \$7,750.00 to be paid from G/L account 500.000.000.5250.490. Funding will be covered out of available funds in the FY 20-21 CIP from the Fox Creek Greenway Trail (Project No. 0510 046 2020).

BACKGROUND: A developer is currently in the process of developing lands in this area which will include the greenway along Fox Creek. The development of this property, currently known as Pavilion Park, will require parkland dedication. It is anticipated that the greenway along Fox Creek will provide for these requirements. Staff wants to ensure that a trail can be placed along the greenway, including connecting to existing Whisper Point Park and other developments in this area. Civil Design Advantage has been working for multiple developers in this area, and recently for the City on the design of Whisper Point Park, so they have a good understanding of the area. Staff requested CDA provide a proposal for preliminary design services to determine trail feasibility and general location at this time. If feasibility of the trail is determined, a new agreement would be forthcoming for the design and construction administration of this trail.

The agreement with Civil Design Advantage, LLC is attached along with their proposal, scope of services, schedule and fees. Civil Design Advantage was selected for this project due to their previous work in this area, and past experience in this type of work. The City retains professional consultants based on their past work experience, qualifications, and availability.

FINANCIAL IMPACT: Total contract amount of \$1,009,917.20. The project will be paid with budgeted CIP funds from G/L account 500.000.000.5250.490. Funding will be covered out of available funds (\$950,000 FY 20-21) in the Sugar Creek Greenway Trail, Phase 1 project account (0510 048 2020). Staff is also requesting approval to cover the remaining portion using available funding (\$400,000 FY 20-21) from the Woodland Hills Trail & Bank Stabilization (0510 090 2015). Sections of the Woodland Hills Trail are now anticipated to be installed by parkland dedication requirements on recently proposed residential development in this area, allowing for remaining funding to cover overages on the Sugar Creek Trail.

BACKGROUND: The Council is asked to approve the plans and specifications for the Sugar Creek Greenway Trail, Phase 1 and to receive and file the report of bids that is attached. Nine (9) bids were received for the project with the lowest responsible bid submitted by RW Excavating Solutions of Prairie City, Iowa. The preliminary estimated cost prepared by Snyder & Associates for the project was \$1,129,832.

This resolution is for Phase 1 of a multi-phased project which will include the construction of trail located on the west side of Sugar Creek between Booneville Rd and just north of Stagecoach Dr. Project will include construction of a 12' wide concrete trail and 10' wide pedestrian bridge over Sugar Creek with a trail connection to Woodland Hills Park. The trail will be constructed of 6" reinforced concrete, will utilize grade separation under new bridges, and will include connections to existing sidewalks located along these streets.

RECOMMENDATION: That the Council hold the public hearing and pass the resolution to approve the plans and specifications, move to receive and file the report of bids, and award the contract for the Sugar Creek Greenway Trail, Phase 1 in the amount of \$1,009,917.20.

FINANCIAL IMPACT: Expense of \$86,000.00 to be paid from G/L account 500.000.000.5250.490. Funding will be covered out of available funds in the FY 19-20 CIP from the Sugar Creek Greenway Trail (Project No. 0510 034 2018).

Under the original approved agreement from 9/3/19, Snyder & Associates **BACKGROUND:** completed professional services related to preparation of construction documents for the Sugar Creek Trail (Phase 1 from Stagecoach Dr to Booneville Road). That scope included preparation of construction documents for this trail segment, as well as a pedestrian bridge across Sugar Creek with connection to Woodland Hills Park. Services included topography and boundary survey, engineering design, structural design for pedestrian bridge, geotech investigation, hydrology/hydraulic studies and project specifications. That contract was amended (Amendment #1) on 5/18/20 to include 1. Survey Tasks (preparation of easement plats for a segment of trail on property owned by the Woodland Hills Homeowners Association, additional staking of property lines, additional topographic survey), 2. Geotechnical Tasks (additional time for soil borings), 3. Final Plan Modifications. This amendment (Amendment #2) is to include construction phase services including 1. Project Administration, 2. Construction Administration, 3. Construction Observation - Trail, 4. Construction Observation - Bridge & Culvert, 5. Construction Observation - Geotechnical, and 6. Record Drawings. The amendment to the agreement with Snyder & Associates is attached along with their scope of services, schedule and fees.
