He stated that they believe this will meet an ongoing need in the community for childcare to be provided to low- and medium-income families, and that they are prepared to meet all state guidelines.

Chairperson Pfannkuch asked for any other questions or comments from the audience and upon hearing none, declared the public hearing item closed.
