Ullestad informed the Commission that the artist, Douwe Blumberg, sent preliminary working drawings of the piece. Ortgies stated there is a plan to potentially drain the pond in November 2021. Based upon this, staff will be discussing options with Blumberg with one being to install the footings for the spheres in the water after the pond is drained this fall.

ITEM: Motion - Approval of Final Proposal - Light Valley Junction Public Art Project

**FINANCIAL IMPACT:** Payment #2 in the amount of \$5,000 will be paid to contracted artist Tim Adams upon final proposal approval. The \$50,000 project cost was approved to be covered in the '20-'21 Public Art Fund budget.

### SYNOPSIS:

The Light Valley Junction Public Art Project Work Group was formed and approved in February of 2020. The Work Group members are:

Julie Eliason (KCL Engineering)
Matt Hauge (Executive Director of the Historic Valley Junction Foundation)
Mike Kunzler (VJ business owner)
Brenda Sedlacek (Commissioner)
Vince Valdez (Citizen, VJ resident)

A Call for Artists was developed and published in July of 2020 by the Light Valley Junction Public Art Project Work Group for a permanent work of art to be placed in the walkway on the west side of the 200 block of 5<sup>th</sup> Street.

The Work Group received submissions from 4 regional artists. An in-person interview of Tim Adams of Webster City, Iowa, was held on November 11, 2020, after which the Work Group unanimously approved a recommendation to contract with Adams. At their regular monthly meeting on December 8, 2020, the PAAC approved a recommendation that City Council approve an artist agreement with Adams. City Council approved the artist agreement with Adams on February 15, 2021.

The Work Group met with Adams in February of 2021 to discuss final proposal details. On March 16, 2021, the Work Group reviewed Adams's final proposal, which was then unanimously approved. With approval of the final proposal, Adams will proceed to development of detailed working drawings.

Both the Work Group and Adams desire that fabrication and installation of the artwork is completed by the fall of 2021.

BACKGROUND: The project Call for Artists and a copy of Adam's final proposal is attached for review.







### ABOUT WEST DES MOINES

The City of West Des Moines, lowa, is a rapidly growing community located within the Des Moines/West Des Moines Metropolitan Area. West Des Moines has a wide array of amenities and culture and has frequently been recognized as a top locality for young professionals. Forbes has rated the Des Moines metro as the #1 city for young professionals. In 2018, Money listed West Des Moines as the #1 place to live in lowa.

At the heart of the city lies the Historic Valley Junction district. This is the community's gathering place and where the City of West Des Moines began. It is a highly desirable place to live, work and play. The commercial district includes some of the City's most historic buildings and most modern retailers. Residents of Valley Junction are proud of their diversity, great schools, and parks. They recognize and celebrate the distinctive character of their neighborhood within the context of West Des Moines' success. In a word, Valley Junction is unique.

### WEST DES MOINES PUBLIC ART PROGRAM

The vision of the City of West Des Moines Public Art Program is the creation of a diverse collection of public works of art of high aesthetic and intellectual quality and excellence, and a program that promotes cultural expression and artistic appreciation. At the heart of the aspiration for public art in West Des Moines is the wish for an authentic, rich and diverse arts culture that is seen and understood as uniquely arising from the community — an arts culture that benefits and enriches all those who are fortunate enough to visit, work, and live in West Des Moines.

The mission of the West Des Moines Public Art Program is to create a city with successful public spaces incorporating public works of art that offer moments of serendipity and the fine grain detail of the public infrastructure. The Public Art Program champions excellence in art, design, architecture and landscape. The Public Art Program and Collection should be the most visible symbols of West Des Moines' commitment to creativity, encouraging diversity of ideas and expression, and promoting tolerance of multiple opinions. A creative city provides humane environments for its residents, business communities and visitors, extends opportunities for life-long learning and helps preserve community histories.

The primary goals of the Public Art Program are to develop an aesthetically interesting environment, to integrate public works of art into public spaces and to promote tourism and the economic vitality of West Des Moines through the enhancement of public spaces.

### **ABOUT THIS OPPORTUNITY**

### "Light Valley Junction" Public Art Statement

Historic Valley Junction is the gathering place that is the heart and soul of West Des Moines — a delightful mix of old and new, bridging generations with unique shops, vibrant events and a walkable hometown feel. Historic Valley Junction is West Des Moines' original main street.

The Light Valley Junction Public Art Work Group wants to celebrate the past, present and future of this unique place through a public work of art. The Work Group wants every person who experiences this specific commissioned artwork to feel a sense of excitement and a connection to the community. The Work Group wants residents and visitors to be enticed to engage with the artwork and feel alive in its presence.

The project will include a permanent commissioned work of art to be sited on public property in a public walkway located on the west side of the 200 block of 5<sup>th</sup> Street. The work of art may be a single piece or made up of multiple pieces and must include the use of light in its design. The total budget for the project is \$50,000. This not-to-exceed total must cover all artist fees, design and engineering including structural and electrical, fabrication, installation, lighting (excluding electrical service), site visits, and other related expenses.

### **SELECTION & PROJECT CRITERIA**

Selection of a finalist or finalists will be based on the following:

- Quality of letter of interest
- Quality of work samples
- Background and prior work experience including community engagement
- Demonstration of project understanding and ability to meet project schedule
- Consideration of project criteria in conceptual design proposal

The artist's concept, final proposal, and ultimately the final artwork will need to meet certain criteria. Artwork should:

- Fulfill the "Light Valley Junction" Public Art Statement (see above)
- Incorporate lighting as an integral part of the artwork
- Be colorful and eye-catching; high-impact and engaging
- Be low maintenance, durable, and resistant to vandalism; able to withstand extreme weather conditions
- Be aesthetically and photographically pleasing; draw people in
- Be appealing both day and night and during all seasons
- Be able to be installed entirely on City-owned public property
- Include a high level of community engagement that is incorporated into the development of a final proposal by the selected artist
- May be one or multiple pieces of art

### **ELIGIBILITY**

### Artist or artist team:

- Must have completed 2 commissioned outdoor public works of art of \$25,000 or more.
   Experience with incorporating lighting elements in public art preferred.
- Must show an understanding of the community of West Des Moines and the Historic Valley Junction district; special consideration will be given to those artists who show familiarity with the district in their proposal (no travel costs will be covered for any preselection site visits).
- Must be a regional artist who currently resides in one of the following states: lowa, Illinois, Minnesota, Missouri, Nebraska, Wisconsin, South Dakota; special consideration will be given to artists with an lowa connection.
- Must be able to participate in a virtual interview, if needed.
- Black, Indigenous, and People of Color (BIPOC) are encouraged to apply.

### SELECTION PROCESS OVERVIEW

This is an open call for artists who meet the eligibility requirements. Artist's submission materials will be reviewed by the Light Valley Junction Public Art Work Group. If necessary, interviews may be conducted with selected artists or artist teams.

Upon selection of an artist or artist team whether based solely upon submission materials or upon interviews, one artist/artist team will be commissioned to develop, fabricate, and install a permanent artwork.



**SYNOPSIS**: A Selection Committee comprised of citizens and commission members needs to be established to review artist submissions for the 2021 WDMurals temporary exhibit. Staff recommends a 5-person committee including the following individuals:

David Ball (Citizen)
Diane Boyd (Commissioner)
Tricia Kubicek (Citizen/Artist)
Aaron Sewell (Parks & Recreation Department Advisory Board member)
Amenda Tate (Future Commissioner)

**BACKGROUND:** David Ball applied to be a member of the Public Arts Advisory Commission through the City Clerk's Office and has expressed interest in being involved with the Public Art Program. Staff are recommending that he be brought into the work of the PAAC through service on this work group. Tricia Kubicek is a former City of West Des Moines employee (Police Department) and an amateur artist who has also expressed interest in the Public Art Program and has enthusiastically shared information about the WDMurals project on social media.

Public Art Master Plan, Section 6.3

### The Public Art/Artist Selection Panels shall:

- Consist of approximately 5 to 8 members. Subject to additional members if the public art project warrants expanded representation.
- Be ad-hoc panels formed for a limited period of time and charged by the Public Arts
   Advisory Commission with recommending public artists for individual projects or groups of projects for specific public art sites.
- Consist of individuals broadly representative of the following categories: artists, arts
  professionals, community members, donors, project architects and/or engineers, landscape
  architects, project managers, and others as deemed appropriate.
- Author and approve a public art philosophy statement for each proposed public art project. The public art statement will outline community values, beliefs to be expressed by the public art project, and share this statement with the community and selected public artists. The public art statement must be officially approved by the Public Arts Advisory Commission prior to moving forward with public artist/art selection and public artist proposal submissions.
- Review professional credentials, prior work, proposals, and other materials submitted by public artists for particular projects.
- Recommend to the Public Arts Advisory Commission public artist(s) to be commissioned for a
  project, or who will be engaged to join the design team for public art projects.
- Respond to the charges outlined in the public art project prospectus and project guidelines,
   concerning the requirements and concerns addressed within the particular project.
- Be sensitive to the public nature of the project and the necessity for cultural diversity in the Public Art Program and Collection.
- Continue to meet, when appropriate, to review the selected public artist's design concepts.
