West Des Moines City Council Proceedings Tuesday, January 19, 2021

Mayor Steven K. Gaer opened the regularly scheduled meeting of the City Council of West Des Moines, Iowa, in the Council Chambers of the West Des Moines City Hall on Tuesday, January 19, 2021 at 5:30 PM. Council members present were: R. Hardman, G. Hudson, M. McKinney, and K. Trevillyan. Council member R. Trimble participated via teleconference.

City Clerk Ryan Jacobson stated staff is recommending the agenda be amended to remove Item 4(q) Conveyance of Property Interest for Channel Repair Program. He also noted the Resolution for Item 7(a) Covenant Cove Plat 2 has been amended to remove the condition of approval.

Council member Trimble requested that staff and the contractors ensure there is strong communication with the homeowners before digging on their lawns and ensure they do a really good restoration job after the conduit installation.

Brian Hemesath, City Engineer, stated staff is working with JCG Land Services and Strategic America to create construction communication to distribute to homeowners. He also noted most of the conduit installation will cause very minimal damage to residents' yards, but any restoration needed will be done immediately.

On Item 5(a) Funding Allocations for Citywide Housing Programs, initiated by the City of West Des Moines (Continued from January 4, 2021)

Council member Trimble stated he has spoken with staff and learned more about these housing programs, and he noted the current two-year waiting list is not atypical. He recommended that \$25,000 of the funding allocation for the rental housing development support be allocated to the

owner-occupied rehabilitation, which would help fund the rehabilitation of two additional homes on that program's waiting list.

It was moved by Trimble, second by Trevillyan to adopt Motion - Approval of Subcommittee Recommendation with the following amendments: the allocation for Rental Housing Development Support decreased from \$400,000 to \$375,000 and the allocation of Owner-Occupied Rehabilitation increased from \$100,000 to \$125,000.

Council member McKinney stated he initially wanted to see some of these funds used to provide assistance for struggling small businesses; however, after speaking with staff, he has learned that is not an option for these funds, so he supports the amended motion made by Council member Trimble. He stated he still would like staff to research options for providing financial assistance to small businesses.

Council member Trevillyan expressed support for the amended motion, as he was frustrated about the two-year waiting list for the owner-occupied rehabilitation program. He also requested that staff look into changes to the process, as they currently wait until the funding is available for an application before determining if the applicant is eligible.

Council member Hardman expressed support for the amended motion. She also stated the City needs to continue the conversation on the issue of affordable housing and continue seeking incremental progress on that issue.

Council member Hudson expressed support for the amended motion. He noted these housing programs help make our community stronger, and he expressed appreciation to his fellow elected officials and staff for their support of these programs.

Mayor Gaer noted the comprehensive plan update could help identify where affordable housing should go in West Des Moines.

Mayor Gaer asked if any written comments had been received. The City Clerk stated on a vote of 5-0, with two members absent, the Plan and Zoning Commission recommended City Council approval of the comprehensive plan amendment.

Mayor Gaer asked if there were any public comments; hearing none he declared the public hearing closed.

It was moved by McKinney, second by Trevillyan to adopt Resolution - Approval of Comprehensive Plan Amendment.

Mayor Gaer asked if any written comments had been received. The City Clerk stated none had been received.

Mayor Gaer asked if there were any public comments; hearing none he declared the public hearing closed.

It was moved by Trimble, second by Hardman to consider the first reading of the ordinance.

On Item 6(e) Mayor Gaer indicated this was the time and place for a public hearing to consider Ginger West, initiated by the City of West Des Moines. He asked for the date the notice was published and the City Clerk indicated the notice was published on January 8, 2021 in the Des Moines Register. Mayor Gaer asked if any written comments had been received. The City Clerk stated none had been received.

Mayor Gaer asked if there were any public comments.

Mark Lee, Lee Chamberlin Consultant Engineers, stated he is speaking on behalf of a property owner that is in favor of the proposed project but is not in favor of the proposed alignment for Grand Avenue shown on the map included with the council communication. He stated they would be willing to discuss their concerns regarding the proposed alignment with City staff.

Mayor Gaer asked if there were any additional public comments; hearing none he declared the public hearing closed.

Council member McKinney stated he will abstain on this item due to a potential conflict of interest.

It was moved by Trimble, second by Trevillyan to adopt Resolution - Approval of Acquisition of Agricultural Property.

Council member Trimble inquired if the Grand Avenue alignment has been finalized.

Brian Hemesath, City Engineer, responded Grand Avenue might not even be constructed as part of this project. If Grand Avenue is constructed, there are not many options for the alignment, so it would likely be very close to the proposed alignment shown on the map.

Mayor Gaer asked if any written comments had been received. The City Clerk stated none had been received.

Mayor Gaer asked if there were any public comments; hearing none he declared the public hearing closed.

It was moved by Hardman, second by Hudson to adopt Resolution - Approval of Acquisition of Agricultural Property.

Council member McKinney stated he will abstain on this item due to a potential conflict of interest.

On Item 6(g) Mayor Gaer indicated this was the time and place for a public hearing to consider SE County Line Road, Veterans Parkway to SE Soteria Avenue, initiated by the City of West Des Moines. He asked for the date the notice was published and the City Clerk indicated the notice was published on January 8, 2021 in the Des Moines Register. Mayor Gaer asked if any written comments had been received. The City Clerk stated there was one petition received which was included with the council communication.

Mayor Gaer asked if there were any public comments.

Marc Abels, 400 Locust Street, Suite 400, Des Moines, speaking on behalf of the homeowners of Lakeland Estates, stated the petition submitted was signed by every landowner along SE County Line Road, from Veterans Parkway to SE Soteria Avenue, and it requested that the City keep them informed of all plans under consideration and that any improvements to SE County Line Road remain within the existing road right-of-way. He stated the homeowners of Lakeland Estates are generally supportive of the proposed reconstruction of SE County Line Road, however they are absolutely opposed to it becoming a four lane road, as they are concerned

about encroachment on their properties, the removal of landscaping and trees, and the loss of privacy on their property. He noted this acquisition resolution indicates the roadway design has been approved, but city staff have informed him the design has not yet been finalized or approved.

Ben Lors, 8078 45th Lane, Cumming, inquired why the City would approve the acquisition of agricultural property for this project when the design has not yet been finalized. He requested that the City Council defer action on this item until the design is finalized so that the residential homeowners are able to understand the impact.

City Attorney Dick Scieszinski stated it would be appropriate for the City Council to continue this public hearing and bring it back once the design has been finalized.

It was moved by Hardman, second by McKinney to adopt Motion - Continue Public Hearing Indefinitely.

Mayor Gaer asked if any written comments had been received. The City Clerk stated none had been received.

Mayor Gaer asked if there were any public comments; hearing none he declared the public hearing closed.

It was moved by McKinney, second by Hardman to adopt Resolution - Approval of Acquisition of Agricultural Property.

Council member Trevillyan inquired if there is a similar issue with this project as the previous item and the design has not been finalized sufficiently for the property owners to understand the impact of the project.

Brian Hemesath, City Engineer, responded the design for SE Salix Drive is finalized and there will not be any changes to the proposed alignment. He noted the impacted property owners are all aware of the proposed alignment for this project and have not raised any issues with it.

Mayor Gaer asked if any written comments had been received. The City Clerk stated none had been received.

Mayor Gaer asked if there were any public comments; hearing none he declared the public hearing closed.

It was moved by Trevillyan, second by Trimble to adopt Resolution - Approval of Plans and Specifications, Motion to Receive and File Report of Bids, and Resolution - Reject All Bids.

On Item 7(a) Covenant Cove Plat 2, 9637 Heightsview Drive - Replat 22 Lots into 21 Lots and Approve a Site Plan to Allow Construction of Ranch Townhomes, initiated by Covenant Cove, LLC.

It was moved by McKinney, second by Hudson to adopt Resolution - Approval of Preliminary Plat and Site Plan, subject to the applicant complying with all applicable City Code requirements.

Council member Hudson expressed enthusiastic support for this development project.

On Item 8 - Receive, File and/or Refer: no items

On Item 9(a) Legislative Updates

Jamie Letzring, Deputy City Manager, reported the beginning of this legislative session has been active, as 130 bills have been filed in the Senate and 170 bills filed in the House. She noted staff is closely monitoring HSB 34 regarding enforcement of massage therapy and cosmetology.

Council member McKinney noted the MidAmerican Energy RecPlex opening date in the Hy-Vee naming rights agreement, which was amended tonight, is being pushed back to August 2021, and he inquired if that is now the anticipated opening date.

City Attorney Dick Scieszinski responded the original agreement had an opening date of January 2021, but the project's delays forced them to amend the agreement to extend that date. They

agreed upon a conservative estimate for an opening date of August, although staff anticipates it should be open much sooner than that.
The meeting was adjourned at 6:31 p.m.
