B. Director of Parks and Recreation

Ortgies updated the Commission regarding the DART Art Shelter project. This program will involve a Call for Artists and a jury to select artists that can be used by individual cities for Art Shelters within each community. Ryan Crane was appointed to this jury. There have been three potential Art Shelter locations identified in West Des Moines. Bravo has provided a \$250,000 grant to DART to fund the art and artist fees. This project incorporates other communities outside of West Des Moines.
