West Des Moines City Council Proceedings Tuesday September 7, 2021

Mayor Steven K. Gaer opened the regularly scheduled meeting of the City Council of West Des Moines, Iowa, in the Council Chambers of the West Des Moines City Hall on Tuesday, September 7, 2021 at 5:30 PM. Council members present were: R. Hardman, G. Hudson, M. McKinney, K. Trevillyan and R. Trimble.

City Clerk Ryan Jacobson stated staff is recommending the agenda be amended to remove Items 4(f)1 Professional Services Agreement - Delati ITS, LLC and 4(f)2 Professional Services Agreement - Tello ITS Solutions, LLC.

On Item 1. Agenda. It was moved by Trevillyan, second by McKinney approve the agenda as amended.

Council member Trimble arrived at 5:31 p.m. The attendance was re-taken. Council members present were: R. Hardman, G. Hudson, M. McKinney, K. Trevillyan and R. Trimble.

On Item 2. Public Forum:

Troy Zeleznik, 2512 Meadow Lane, expressed concerns about non-conforming trees and weeds growing on a City-owned drainage channel parcel near the intersection of 27th Street and Meadow Lane.

On Item 3. Council/Manager/Other Entities Reports:

Council member McKinney reported he attended a meeting of the Development and Planning Subcommittee, where discussion was held on a proposed multi-use development near the intersection of Ashworth Road and Jordan Creek Parkway and the Railroad Park Restrooms project.

Council member Trevillyan reported he will hold a Ward 1 quarterly town hall meeting on Saturday, September 11th.

Council member Trimble reported the Finance and Administration Subcommittee met and discussed potential development projects in Valley Junctions, the possibility of establishing an Economic Development District for central Iowa. He reported the Public Safety Subcommittee also met and discussed the potential use of the East Public Services Facility as a backup facility for Westcom, the approval process for waivers of ambulance fees, the future location of the Independence Day fireworks, the potential shared facility with the National Guard, and a review

of the Westpet 28E agreement.

Council member Hudson congratulated Public Services Director Bret Hodne on the opening of the new West Public Services Facility.

Council member Hardman reported she attended the Development and Planning Subcommittee. She stated there have been discussions about a partnership between the City and the West Des Moines Community School District for a skilled trades program, and she expressed support for the program. She also reported the City has hired Audrey Kennis as its first Diversity, Equity, and Inclusion Director. She expressed appreciation to Katherine Harrington, President/CEO of the West Des Moines Chamber of Commerce, for hosting the inaugural Diversity, Equity, and Inclusion Workplace Excellence Awards, which was a phenomenal event that highlighted diversity, equity, and inclusion initiatives in our city. She also stated the Taste of the Junction Multicultural Festival was held on Saturday, and she congratulated Rachelle Long for organizing a successful event.

City Manager Tom Hadden requested that staff provide an update on the University Avenue Corridor Study.

Clyde Evans, Community and Economic Development Director, reported there is a draft plan review session with the advisory committee scheduled for September 22nd. There are plans to hold a joint meeting between the Plan and Zoning Commission and City Council on October 4th. The week of October 11th, there will be follow-up discussions with shareholders, and a draft plan open house would be scheduled for October 20th. The final draft would then be scheduled for review by the advisory committee on November 3rd, the Plan and Zoning Commission on November 8th, and then the City Council on November 15th.

Council member Trimble stated he has received complaints from residents who have had the right-of-way in front of their homes disturbed for this project and are dissatisfied with the restoration job done by the contractors. He requested that staff continue to emphasize with the contractors the importance of restoring the ground back to what it was before.

Mayor Gaer inquired if the rejection of these bids and re-bidding the project will cause a delay in providing service to those properties.

Brian Hemesath, City Engineer, responded staff does not anticipate this causing any significant delays.

Council member Trevillyan inquired if staff knows the reason why only two bids were received.

Mr. Hemesath responded staff believes the reason for receiving only two bids was because the scope of this project was so large, and staff anticipates splitting the project into multiple sections would attract more bids.
