# A. Motion – Approve Recommendation for Bicycle Facilities – Boonville Road from South Jordan Creek Parkway to South 88th Street

Peterson updated the Commission on the current Bicycle Master Plan which shows a future onstreet bicycle facility on Booneville Road. A bike route is still desired to connect to a future park and sidepath trails on South Jordan Creek Parkway and South 88<sup>th</sup> Street. Given the forecasted traffic volume and speed, a sidepath trail is being planned for Boonville Road instead of an onstreet facility. Petersen is seeking approval from the Commission to modify the Bicycle Master Plan to remove the planned on-street facility on Boonville Road from South Jordan Creek Parkway to South 88<sup>th</sup> Street to be replaced with an off-street sidepath trail. Moore moved to approve the recommendation as presented by staff. Motion carried, 4 ayes.

Dave Millburn provided an update on Johnston's efforts in improving their trail development efforts to better connect Johnston to the surrounding Central Iowa trails. Currently, it is challenging if one is trying to get to the Central Iowa trails on a bike from Johnston. A group called Johnston Trailblazers have been

meeting over the past few months. The goals of this group is to better connect Johnston to the surrounding regional trail system, improve safety, wayfinding and promote creation of Bike and Water Trailhead at Merle Hay and I-80. They have received support from the AARP and helped secure \$15,000 grant funding for wayfinding improvements. Dave shared the wayfinding design concept developed.

#### 6. UPDATE: 2021 Bike Month, Mike Armstrong, Street Collective

Mike from Street Collective announced that September is being celebrated as Bike Month this year instead of May with a variety of community events, rides, and fundraising efforts planned for the entire month. Most events are outside. Several new events are planned this time. All information and a calendar of events are available on their Facebook page as well as on their website at <a href="https://www.dsmstreetcollective.org/bike-month-sept">https://www.dsmstreetcollective.org/bike-month-sept</a>. In the future there are plans to include pedestrian and transit related activities in addition to bikes only.

# 7. DISCUSSION: Motorized Devices on Trails Follow-up Discussion, Roundtable

The discussion regarding the issue of allowing motorized devices such as one wheelers on trails was recapped again. Roundtable members saw a demonstration last month to see how they performed on the trails. The general preference so far has been to develop a criteria-based allowance rather than a blanket policy across the board. The Des Moines Trails and Greenways Committee is also looking at this issue and saw a demo as well. Some residents have also reached out to City of Des Moines to ask about being able to commute on these on the trails. One of the demonstrators indicated they sell about 10 of these a week. Therefore there is expectation for this conversation to continue. All the different policies out there should be talking to each other.

#### 8. UPDATE: MPOs Permanent Trail Count Program, MPO

The MPO kicked off its permanent trail counter program earlier this year and programmed funding to install three permanent multi use counters. Those counters have now been installed – one along Copper Creek Lake on GLW Trail, the second on CVT north of I-80, and the third on HTT north of Ankeny. MPO staff shared count data that is uploaded daily. The MPO has also secured \$24, from the Wellmark Foundation for installation of the next 5 counters. Staff will work with communities to finalize the next five locations for installation of the counters over the next few months. The MPO also intends to make available these counts through an interactive map so it is easily accessible to anybody who might need the count data.

#### 10. Project Updates

City of Des Moines – Bill Riley Trail Underpass was completed mid July, Meredith Trail landslide between 7th and 9th Street bridges is nearly complete and expected to be open in September for Bike Month, work around Principal Riverwalk wrt levy improvements is starting to wrap up in the Spring of 2022, the John Pat Dorian and Carl Voss Trail on the east side of the River will be impacted by the levy improvements and then they'll jump back to phase B on the north side.

For those that are interested in the connection between the High Trestle Trail and RRVT, construction on the next two phases has begun, two phases are complete and construction on next two have begun, working on fundraising for the rest.

FINANCIAL IMPACT: Expense of \$23,625.00 including reimbursable expenses to be paid from G/L account 500.000.000.5250.495. Funding will be covered out of available funds in the Trail Renovation CIP (Project No. 0510 027 2020).

Council is asked to approve an agreement with Bolton & Menk, Inc. for BACKGROUND: professional services related to preparation of plans for the renovation of multiple sections of concrete trail. The renovations include primarily the redesign and replacement of concrete ramps located at street crossing and bringing them into compliance with ADA. The agreement includes all work necessary for the design of these ramps, bidding services and construction administration.

The consultant was selected due to their past experience in this type of work. The agreement with Bolton & Menk is attached along with their proposal, scope of services, schedule, and fees.

# Bicycle Advisory Commission Goals and Objectives for 2021-2023

(Status update on objectives as per 10/28/21)

# **Engineering Goals**

- Provide a safe and enjoyable trail system
- Develop trail connections with other Des Moines metro cities and counties
- Provide safe and convenient bicycle access to the community
- Ensure that the trails and on-street bikeways are properly designed and maintained
- Expand the bike network and increase connectivity through the use of different types of on-street bicycle facilities
- Increase amount of bicycle parking at popular destinations
- Adopt a complete streets policy

#### **Engineering Objectives**

- A. Incorporate bicycle friendly components into the University Avenue Corridor Redevelopment. Status: This plan is currently in the works and does include multiple bicycle friendly components. High level discussion items have included designated bike lanes along Westown Parkway and N/S bike lanes as connections between WDM and Clive along 28th and 42nd. Also recommending other bike and ped improvements including refuge islands at major street crossings, public transportation hubs, and other improvements to expand equity.
- B. Update Bicycle Master Plan to reflect the city's updating of the Comprehensive Plan Status: Development Services Department currently working on update for Comprehensive Plan. Parks staff has looked at some of the preliminary updates, but Bicycle Master Plan cannot be officially updated until the Comp Plan is formally updated and approved.
- C. Further expand trail network and connectivity (another possible objective)
  Status: Although not necessarily on street facilities, several segments of side path trails are currently being added and incorporated into several major street projects including Grand Prairie Parkway (south of Mills Civic), Grand Avenue (west of 88th Street), and County Line Road (east of Veteran's Parkway

#### **Education Goals**

- Promote overall safety awareness for bicyclists
- Educate street users, both cyclists and drivers, to share the streets and interact safely
- Provide education on laws related to bicycling to both bicyclists and motor vehicle drivers

# **Encouragement Goals**

- Promote recreational/family riding and trail safety
- Enhance the trail and on-street bike facility signage program with wayfinding signs
- Promote bicycling in general and communicate the many benefits of bicycling
- Encourage employers to facilitate bicycle use among employees
- Promote intermodal travel public transportation and bicycling
- Provide broad range of bicycle facility choices for users of various abilities and comfort levels

# **Education and Encouragement Objectives**

- A. Promote BAC initiatives via social media with a focus in May for Bike Month
  - \* BCycle station in RRP
  - \* New rider education
  - \* Helmet promoting

\* Provide practical info such as metro maps

Status: This will be the third year for the BCycle station at RRP. This is managed by the Iowa Bike Collective and has been very successful. They noted it was in the top 5 most used stations in the metro. Parks and police staff applied for a WDM Community Foundation grant for a bike helmet program. This provided funding to purchase a new bike pull cart and helmets that are distributed as part of the Police Department's Bike Patrol program. Several helmets have been distributed throughout the summer months. New sharrow lines were painted in June 2021.

- B. Revamp Mayors Bike Ride
  - \*Move to a different date
  - \*Partner with another event
  - \*Trails vs on street
  - \*Change name? "Bike Day or Bike Festival"

Status: This year's Mayors Annual Bike Ride was again held in May at Raccoon River Park. This was one of the more successful rides likely due to excellent weather. Incorporated a pancake breakfast and there were an estimated 75 riders in the event.

- C. Promote in person events
  - \*HyVee events
  - \*Ice Cream socials
  - \*Bike Day in May
  - \*4th of July parade (move Bike Camp to week before?)
  - \*Amphitheater events

Status: Held a series of Ice Cream socials throughout the summer at (3) newer neighborhood parks. Parks and Recreation Staff, along with members from Park & Rec Advisory Board, Friends of WDM Parks, and BAC present to promote their respective initiatives.

- D. Increase availability of bike usage
  - \*Look into rentable bikes at RRP Boathouse
  - \*Additional BCycle stations
- E. Promote additional partnerships
  - \*Public Art Commission

Status: Staff initiated "Walk & Roll" theme for next year's WDMurals program which will encourage artists to depict how trails are used in their designs. Appointed BAC commissioner onto the selection committee.

- F. Trail Signage
  - \*Education and Wayfinding
  - \*Trail etiquette

#### **Enforcement Goal**

- Ensure all applicable City policies, plans, codes and programs are updated, implemented, and enforced
- Protect the rights of cyclists to operate legally on the roads, protect cyclists against careless, reckless or dangerous driving, and ensure cyclists follow the laws and operate safely

#### **Evaluation Goals**

- Evaluate bicycle related projects and collect usage data
- Reduce the number of bicycle crashes in the community
