Monday, March 7, 2022

Mayor Russ Trimble opened the regularly scheduled meeting of the City Council of West Des Moines, Iowa, in the Council Chambers of the West Des Moines City Hall on Monday, March 7, 2022 at 5:30 PM. Council members present were: R. Hardman, G. Hudson, D. Loots, and K. Trevillyan.

City Clerk Ryan Jacobson stated staff is recommending two amendments to the agenda: the removal of Item 3(a) Recognition of Governor's Life Saving Award Recipient, which will be moved to the March 21st agenda, and the removal of the Workshop on a Process for Citizen Complaints, which will be rescheduled for a later date.

On Item 2. Public Forum:

M.J. Hoag, 413 2nd Street, stated he is disappointed the proposed project for Item 4(e)6 Park Parking Lot and Sidewalk Improvements does not include the alternative parking option he suggested for American Legion Park, but he thanked the City Council and staff for giving consideration to his request.

On Item 3. Council/Manager/Other Entities Reports:

Steve Frevert, Executive Director of the Historic Valley Junction Foundation, and Meredith Wells, Board President, provided an update on the organization's activities.

Council member Hardman reported she participated in a meeting regarding the honorary roadway naming process, and she expressed appreciation to staff for their efforts in developing that process. She reported she also attended a stakeholder meeting with Bravo Greater Des Moines. She noted this week she will be attending a Human Rights Commission meeting and a Valley Junction Master Plan Steering Committee meeting. She also stated she will participate in Mentoring for Women event, hosted by the West Des Moines Chamber of Commerce.

Council member McKinney reported he attended a meeting of the Public Services Subcommittee, where discussion was held on right-of-way management. He also attended a

Council member Hudson expressed appreciation to the Public Services Department for their snow removal efforts following the recent winter weather.

Mayor Trimble reported the Des Moines Area Regional Transit Authority is lobbying the Iowa Legislature to pursue alternate revenue sources. He also stated the budget workshop dinner was a great event, and he expressed appreciation to staff for all their efforts towards keeping the City operating.

He requested that the Council deny the request for that northern portion so the residents could work with the developer towards a mutually agreeable solution on the layout of the site and its setbacks and sight lines.

Ed Arp, Civil Engineering Consultants, speaking on behalf of the applicant, stated the concerns about setbacks and sight lines are difficult to address as part of this zoning process and would be better addressed later during the site plan process. He noted the applicant intends to sell the property to another developer, so those discussions would need to involve the next developer at the time it goes through the site plan process.

Mayor Trimble asked if there were any additional public comments; hearing none he declared the public hearing closed.

Lynne Twedt, Development Services Director, reported the property is currently zoned office, so if the Council removed the northern portion from the proposed rezoning ordinance, that portion would remain as office, which is not a good fit for the neighborhood. She noted if the proposed ordinance is adopted as-is and the northern portion is rezoned as medium-density residential, the minimum setback would be 30 feet. She also stated the developer has expressed an interest in doing some berming along the property line.

Mayor Trimble noted that there is also a 150-foot buffer in which the developer could not construct anything taller than two stories. He suggested that Mr. Cutler provide his contact information to staff, and he requested that staff notify Mr. Cutler when the site plan comes through for this development.

On Item 9(a) Legislative Updates

Jamie Letzring, Deputy City Manager, reported that HF 2317 regarding tax reform was passed and has been signed by the Governor, and it will incrementally lower the individual income tax rate to 3.9 percent by 2026. She reported the City is following pending legislation being considered in the Senate regarding municipal franchise fees. She also provided a report on SF 2361 regarding workforce and housing, which would restrict the City's authority to enforce zoning regulations and could include universal building and fire codes across the State of Iowa. She noted that City staff have concerns about this legislation, but the City is currently registered as undecided and is working with its lobbyists to request amendments that would address the concerns of City staff.

Council member Hardman expressed concerns about the potential negative impacts SF 2361 could have on public safety, and she requested to hear our Fire Department professionals' perspective on it.

Fire/EMS Chief Craig Leu stated SF 2361 would take local control away from the City to have its own building and fire codes. He also stated the City currently uses the 2018 code, but this would roll it back to the 2015 code. He noted that using the more current code is one way the Fire Department can limit the number of staff needed to protect our community. He also reported the proposed legislation would require building plan reviews to be routed through the State Fire Marshal's Office, which only has three inspectors, so it could significantly slow down the process for growth in our city.

Council member Hardman expressed opposition to SF 2361 in its current form, because it would take local control away from the City and could have a negative impact on public safety.

On Item 9(b) Comprehensive Plan Update

Lynne Twedt, Development Services Director, provided a report on the Comprehensive Plan Update process and the work completed thus far. She stated staff intends to hold a Council workshop following the March 21st Council meeting, and there will then be a 30-day public comment period before the Comprehensive Plan Update is formally considered in a public hearing process by both the Plan and Zoning Commission and the City Council in May.

The Mayor and Council expressed support for the "place types" concept, which will give developers flexibility while still providing assurance to property owners about what uses could be located near their property. They also expressed appreciation to staff for their efforts throughout this Comprehensive Plan Update process.

The meeting was adjourned at 7:57 p.m.
