ITEM: Holiday Park ROW Vacation – Vacate 19,625-square feet of right-of-way including an excess of approximately 450' of public alleys and 107' of Maple Street located near the intersection of Maple Street and 14<sup>th</sup> Street – City of West Des Moines – VAC-005500-2022

**ORDINANCE: Approval of Vacation Request** 

**Background:** Marco Alvarez with City of West Des Moines Parks and Recreation Department, on behalf of the applicant and property owner, City of West Des Moines, requests approval of the vacation of that portion of excess right-of-way within two existing public alleys and Maple Street situated near the intersection of Maple Street and 14<sup>th</sup> Street. The roadway segment subject of this request has been determined by City staff to no longer be necessary. The purpose of this action is to vacate excess street right-of-way so that newly defined lots can be tied together within Holiday Park to create a contiguous development parcel. As part of the vacation, a Reservation of Permanent Easement is requested for the purpose of accessing any public utilities within the easement area.

#### **Staff Review & Comment:**

- <u>History</u>: In 2021, the city's Park and Recreation Department requested improvements to the existing maintenance building supporting Holiday Park near the intersection of Maple Street and 14<sup>th</sup> Street. Upon review of their proposal, it was determined that a portion of the existing building was constructed within a 33' alley right-of-way. Their improvement proposal also included paving the existing gravel parking area on-site which was also located within 107' of the right-of-way of Maple Street. The excess right-of-way must be vacated to allow for the improvements.
- <u>Public Utilities</u>: There are several known public utilities contained within these right-ofway areas (sanitary sewer, storm sewer and fiber) and they will remain. The City will reserve a permanent utility easement over the right-of-way areas for use by these utilities. The approval of the reservation of permanent easement will be included in the City Council approval of this Vacation.


