ITEM: Ordinance Amendment, Amend Title 9 (Zoning) to allow Beauty Shops and Barbershops in the Professional Commerce Park Zoning District – Penta Partners LLC – AO-005652-2022

RESOLUTION: Approval of Ordinance Amendment

<u>Background</u>: Penta Partners LLC requests an amendment to the chapters and sections identified below in Title 9 (Zoning) to allow SIC 723: Beauty Shops and SIC 724: Barbershops in the Professional Commerce Park (PCP) Zoning District.

Specifically, the following changes are proposed with this request:

- Title 9: Zoning
 - Chapter 6: Commercial, Office and Industrial Zoning District, Section 6: Commercial, Office and Industrial Use Regulations, Subsection 6C: Table 6.1 Use Matrix, Division I Services to add SIC 723 Beauty Shops and SIC 724 Barbershops as a Permitted Use in the Professional Commerce Park zoning district.

Staff Review & Comment:

• <u>Ordinance Amendment Intent</u>: The intent of the Ordinance Amendment is to allow Beauty Shops and Barbershops in the Professional Commerce Park zoning district.

Staff received a Tenant Improvement Permit for a 4,400 square foot tenant space in the office building located at 7300 Westown Parkway. The applicant was looking to develop an 'all-encompassing personal wellness experience' which included space for massage therapy, nonsurgical aesthetic medical services under the supervision of a licensed physician (aka MedSpa), skin care therapist (estheticians) and cosmetology, specifically hairstylists. The permit was denied as the esthetician and cosmetology services were not permitted in the zoning district in which the building is located.

With a portion of the uses being allowed in PCP and determining that the balance of the uses desired operate similarly without any different or greater impacts, staff agreed that Beauty Shops, includes estheticians (SIC 723) and Barbershops (SIC 724) would be complimentary uses and made sense to be allowed in the Professional Commerce Park (PCP) zoning district. The request was discussed with the Development & Planning Subcommittee at the June 6, 2022 meeting. The Subcommittee agreed with amending City code to add Beauty Shops and Barbershops as allowed uses.

ORDINANCE NO.

AN ORDINANCE AMENDING THE CITY CODE OF THE CITY OF WEST DES MOINES, IOWA, 2019, TITLE 9, (ZONING), CHAPTER 6 (COMMERCIAL, OFFICE AND INDUSTRIAL ZONING DISTRICT), PERTAINING TO ALLOWED USES IN THE PROFESSIONAL COMMERCE PARK DISTRICT

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WEST DES MOINES, IOWA:

Section 1. <u>Amendment.</u> Title 9: Zoning, Chapter 6: Commercial, Office and Industrial Zoning District, Section 6: Commercial, Office and Industrial Use Regulations, Subsection 6C, Table 6.1 - Use Matrix, Division I - Services, is hereby amended by inserting the text in bold italics. All other items in current adopted table but not reflected below shall remain as currently adopted:

Section 2. Repealer. All ordinances of parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

Section 3. Savings Clause. If any section, provision, sentence, clause, phrase or part of this Ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the Ordinance as a whole or any provision, section, subsection, sentence, clause, phrase or part hereof not adjudged invalid or unconstitutional.

Section 4. Violations and Penalties. Any person who violates the provisions of this Ordinance upon conviction shall be punished as set forth in Title 1, Chapter 4, Section 1 of the City Code of the City of West Des Moines, Iowa.
