

Amendment to City code to the following:

- Title 9: Zoning
 - Chapter 6: Commercial, Office and Industrial Zoning District

Intent:

- Amendment to allow National Security facilities (SIC 9711) in the General Industrial (GI) zoning district for a new Army National Guard (ARNG) Readiness Center at 1998 SE Maffitt Lake Road. This SIC Code encompasses establishments of the armed forces, including the National Guard, primarily engaged in national security and related activities.
- Staff supports the addition of the use in the General Industrial zoning district as a Permitted use as it allows more intense site features, like outdoor storage of vehicles and equipment, necessary for the proposed development.




