# Item 3a -X Golf, 165 S. Jordan Creek Parkway, Suite 135 - Approval to establish an indoor golf simulator facility with a bar/restaurant - Colby's Bridgewood Plaza, LC - PC-005877-2022

Chair Stevens asked for clarification of which suite this occupies in the Plaza. Mr. Sloden stated it was formerly the Iowa Realty space.

Board Member Blaser questioned whether the applicant planned to use an outdoor patio space in the future and whether that would come back before the City. Mr. Sloden stated they do plan to expand to outdoor patio use in the future but will work to establish relationships with adjacent tenants currently using patio space first. He affirmed that approval would be required by the City prior to use.

Chairperson Stevens asked for any other questions or comments from the audience and upon

Brian Portz, Development Services Planner, informed that the request is for permitted conditional use for two land uses, the bar/restaurant, and the golf simulators. Both are required by City Code to have a permitted conditional use permit.
