West Des Moines City Council Proceedings Monday, February 5, 2024

Mayor Russ Trimble opened the regularly scheduled meeting of the City Council of West Des Moines, Iowa, in the Council Chambers of the West Des Moines City Hall on Monday, February 5, 2024 at 5:30 PM. Council members present were: R. Hardman, G. Hudson, M. McKinney, and K. Trevillyan.

City Clerk Ryan Jacobson stated staff is recommending the agenda be amended to continue Item 5(a) Amendment to City Code - Open Space Zoning District to the March 4, 2023 Council meeting.

Jana Rieker, Amplimark, presented an overview of the City of West Des Moines Communications Plan.

Todd Sadler, Human Resources Director, and Police Chief Chris Scott presented an overview of the key recommendations from the study of police services that was recently completed by the Center for Public Safety Management, LLC.

City Manager Tom Hadden reported he is excited to implement the communications plan and the Police department recommendations that were presented tonight. He also expressed appreciation to Police Chief Chris Scott and the Police Department for their willingness to continue striving for improvement.

Council member Hudson reported the Finance and Administration Subcommittee has now heard presentations from the 20 organizations that applied for hotel/motel tax funding. He also reported the Public Safety Subcommittee met and received updates from staff, which included an update on the proposed contracts for EMS and Fire Department Medical Directors that are on tonight's agenda. He also reported the Library Board of Trustees is currently conducting a search for the new Library Director. He commended the Parks and Recreation Department for their efforts in obtaining grant funding and raising funds through private donations to help finance their quality of life projects.

Council member McKinney reported the Development and Planning Subcommittee met and discussed the proposed data center development projects, Microsoft DSM 16 and DSM 17.

Council member Hardman expressed condolences for the recent passing of Gordon Loots, father of Council member Doug Loots. She also reported she attended the Bravo Awards Gala, hosted by Bravo Greater Des Moines. She expressed support for the Black History Month proclamation and commended Audrey Kennis, DEI Director, for the work she does to recognize minoritized groups. She encouraged everyone to seek connections with individuals that are different from themselves and to honor cultures that are different from their own.

Mayor Trimble reported the Des Moines Area Regional Transit Authority is working on solutions to resolve its current budgetary challenges.
