# WHO MAY ENTER THE PARADE?

Local businesses, organizations, drill teams, dance schools, sports teams, civic groups, churches, youth groups, clowns, horses, and neighborhoods can enter. If accepted into the parade, you will receive instructions and information approximately one week before.

# WHAT ARE THE ENTRY REQUIREMENTS?

- 1.) Submit the registration form by **June 24**.
- Decorate your entry with streamers, balloons, tissue paper, or play music.
   The more creative you can be, the better the parade will be for those watching.
- 3.) Costumes/uniforms: If you are entering your sports team or drill team, have your members dress in costumes or uniforms.
- 4.) Candy/handouts: These items are allowed provided you plan a safe way to distribute them to the spectators. It is highly encouraged to have walkers walk along with the crowd and distribute their candy to the crowd.
- 5.) Water guns are NOT allowed.
- 6.) Semi trucks/trailers are NOT allowed.
- 7.) Sirens are NOT allowed.

# WHAT IS THE PARADE ROUTE?

The parade will start heading east at Valley West Dr. and Ashworth Rd. Then turn south on Vine St. and proceed to 16th St. Turn south on 16th St. Turn east on Locust St. Finally, turn south on 9th St. and conclude at Elm St. at Wilson/Holiday Park.
