West Des Moines City Council Proceedings Monday, June 3, 2024

Mayor Russ Trimble opened the regularly scheduled meeting of the City Council of West Des Moines, Iowa, in the Council Chambers of the West Des Moines City Hall on Monday, June 3, 2024 at 5:30 PM. Council members present were: G. Hudson, D. Loots, M. McKinney, and K. Trevillyan.

City Clerk Ryan Jacobson stated staff is recommending the agenda be amended to remove Consent Agenda items 4(g)1 Purchase of Body Worn Camera and In-Car Camera Systems and 4(k) Second Amended and Restated Development Agreement - JGC Holdings, LLC and Series 8 of JGC Holdings, LLC. He also stated staff is recommending the agenda be amended to include a motion to continue Item 5(b) Village on Jordan Creek PUD Amendment to the June 17th meeting, when the full Council is expected to be present.

On Item 1. Agenda. It was moved by Trevillyan, second by McKinney approve the agenda as amended.

On Item 2. Public Forum:

Gary Leffler, 1235 11th Street, expressed concerns that a shed on the Jordan House property was broken into and his personal four-wheeler that had been stored there was stolen. He commended the West Des Moines Police Department for their response and successfully recovering his stolen four-wheeler. He reiterated his previous suggestion that there should be a permanent residence established on the property to deter criminal activity. He also expressed concerns that he had been involved in near-collisions between his vehicle and bicyclists traveling on the trail near South 19th Street and Grand Avenue, and he suggested signage or flashing lights be installed to encourage bicyclists using the trail to stop at intersections. He also expressed concerns that the West Des Moines Water Works is digging a hole to shut off the water service for the Legacy Woods property, and he noted a new turn-off valve was recently installed across the street, which could be a less expensive alternative than digging the hole.

Amy Buehrer, 8415 Mills Civic Parkway, expressed concerns that the Council meeting livestream on YouTube is delayed from the live meeting when participating telephonically. She also expressed concerns about audio issues during a previous Council meeting for which she participated telephonically. She requested confirmation that the Mayor and Council received the email she sent earlier today requesting no trespassing and no construction on her property.

On Item 3. Council/Manager/Other Entities Reports:

City Manager Tom Hadden reported the Public Services Department is still working on the storm debris pick up, moving across the city from east to west, but anticipates they will finish the entire by the end of this week. He stated staff will be reviewing the existing policy on storm debris clean-up, and it will be brought to the Public Services Subcommittee for discussion.

The Mayor and Council expressed appreciation to staff for their efforts on the storm debris clean-up process.

Council member Hudson congratulated the approximately 1,000 graduates of local high schools that are residents of West Des Moines, and he wished them well in their future endeavors.

Council member McKinney reported the Development and Planning Subcommittee met and reviewed proposed multi-family and single family development projects, the proposed ordinance regarding open space zoning, and public parking in the Valley Junction Business District. He also reported City Manager Hadden had shared an analysis that indicated hotel-motel tax revenue generated in West Des Moines has increased 21 percent over last year.

Council member Hudson reported the Finance and Administration Subcommittee met and discussed the 2025 Special Partial Census, which will cost the City approximately \$400,000 but is expected to generate an additional \$5.6 million in road use tax revenue over the five years from 2026-2030, so the subcommittee felt this would be a good return on the investment.

Council member Loots reported the Community Compliance Subcommittee met and discussed a proposed ordinance amendment regarding property owner's responsibility for mowing the right-of-way adjacent to their property.

Mayor Trimble reported the Des Moines Area Regional Transit Authority is conducting a study to seek efficiencies in their operations.
