West Des Moines City Council Proceedings Monday, October 7, 2024

Mayor Pro tem Kevin Trevillyan opened the regularly scheduled meeting of the City Council of West Des Moines, Iowa, in the Council Chambers of the West Des Moines City Hall on Monday, October 7, 2024 at 5:30 PM. Council members present were: R. Hardman, G. Hudson, D. Loots, and K. Trevillyan. Council member M. McKinney participated via telephone.

On Item 1. Agenda. It was moved by Loots, second by Hardman approve the agenda as presented.

Vote 24-389: Hardman, Hudson, Loots, McKinney, Trevillyan...5 yes Motion carried.

City Manager Tom Hadden read a statement prepared by Mayor Trimble regarding the Raccoon River Bridges Feasibility Study.

On Item 2. Public Forum:

Margo Blumenthal, 951 South 35<sup>th</sup> Street, expressed concerns about cases of suspected corruption by the City of West Des Moines dating back to 1989.

Theresa Benskin, 900 67<sup>th</sup> Street, spoke in opposition to the construction of any new bridge over the Raccoon River, citing concerns about potential negative impacts to the environment, potential engineering issues with constructing a bridge through a floodway, and the potential negative impacts on the existing property owners in the area, such as increased traffic, noise, and light pollution. She requested that the City Council take note of the citizens' concerns, clarify the necessity for constructing a bridge over the Raccoon River, and visit the locations along the Raccoon River.

Kelley Koch, 36793 Beachwood Drive, Cumming, spoke in opposition to the construction of any new bridge over the Raccoon River, citing concerns about the environmental impact on the Maffitt Lake Reservoir, potential contamination of the public's water supply, and a potential increase in traffic throughout the local streets near the Raccoon River.

Tom Stull, 3530 Commerce Drive, spoke in opposition to the construction of any new bridge over the Raccoon River, and he expressed a desire to preserve the natural beauty and historical significance of the areas near the Raccoon River. He requested that the City Council commit to doing no damage to the Purple Martin Lake, Walnut Woods State Park, the Maffitt Lake Reservoir, or the Chain of Lakes Recreation Area.

Sue Seaman, a resident of the Greenbrier Estates development, spoke in opposition to the construction of any new bridge over the Raccoon River, and she expressed a desire to preserve

the natural beauty and tranquility of the area. She expressed concerns that an increase in traffic could result in an increase in crime and an increase in car vs. deer accidents. She also expressed concerns about potential contamination of the public's water supply.

Jan Goldsmith, 1675 SE Walnut Woods Drive, inquired if the City had provided public notice of the Council's vote on the Raccoon River Bridges Feasibility Study. She also requested clarifications on which areas will be included in the feasibility study.

Mayor Pro tem Trevillyan stated the Council's consideration of the Raccoon River Bridges Feasibility Study was publicly noticed as part of the agenda for the September 16<sup>th</sup> City Council meeting; however, notices were not mailed out to the residents.

Deb Gadlin, 35099 Maffitt Lake Road, Cumming, noted the feasibility study includes areas, such as Maffitt Lake Road, which are outside the corporate limits of West Des Moines, and she inquired if the City plans to annex that area.

Bob Ready, 2195 SE Browns Woods Place, spoke in opposition to the construction of any new bridge over the Raccoon River, citing concerns about a potential increase in traffic on SE Brown's Woods Drive.

Landon Stull, 3530 Commerce Drive, expressed concerns that the professional services agreement for the feasibility study requires that minutes be taken for any meetings held related to the study, but when he inquired with City staff and learned that one meeting had been held, there were no meeting minutes available for that meeting. He requested that the Council enforce that requirement from the agreement and require the consultant to make meeting minutes publicly available.

Mark Cullen, 3428 Scenic Valley Drive, spoke in opposition to the construction of a new bridge over the Raccoon River at South 35<sup>th</sup> Street, because he believes a bridge at that location would not make sense from an economic development perspective or an environmental impact perspective. He stated he believes it is a waste of time and money to include that area in the feasibility study.

Tina Dewey, 4240 High Street, spoke in opposition to the construction of any new bridge over the Raccoon River, citing concerns that it could potentially increase traffic throughout her neighborhood and disrupt the peaceful nature and wildlife of the area. She stated the residents of the areas near the Raccoon River should have been personally notified of the September 16<sup>th</sup> Council consideration of the Raccoon River Bridges Feasibility Study.

Council member Trevillyan requested that everyone in attendance raise their hand if they are opposed to the construction of a new bridge over the Raccoon River, to which a vast majority of those in the room raised their hands. He estimated there were approximately 135 to 140 individuals that had raised their hands.

Brian Hemesath, City Engineer, responded to questions from the Council, stating the City has the ability to do a feasibility for any areas outside the corporate limits but within our future planning areas. He reported the feasibility study will look at all areas along the Raccoon River between South 35<sup>th</sup> Street and just west of South Jordan Creek Parkway, and it will take into consideration the environmental impacts, including archaeological, drinking water, wetlands, and forested areas, and it will identify areas where a possible bridge could be located. He noted the scope of work also includes the preparation of a preliminary design and estimate of costs. He explained that the first meeting with the consultant was to review the scope of work, but he does not believe any minutes were taken of that meeting.

Council member Loots suggested that any future meetings regarding the feasibility study be recorded and posted on the City website, as he believes it would be best to go above and beyond for the sake of transparency.

Council member Hudson stated he does not see how any potential route for a new bridge over the Raccoon River would make sense, and since it would cost approximately \$15 million or more to construct one, he believes there a lot better things the City could do with that amount of money.

Craig Pepper, 2051 South 50<sup>th</sup> Street, inquired if the upcoming widening of I-35 to add a third lane, allowing it to accommodate additional traffic where it passes over the Raccoon River, could alleviate the need for any of the existing local streets to have a bridge spanning across the Raccoon River.

Council member Hardman expressed support for the feasibility study, as its purpose is to provide information. She stated when the study is completed, she will take that information into consideration, along with all the concerns expressed by the residents tonight.

Council member McKinney expressed a desire to retain the environmental, recreational, and historical nature of those areas along the Raccoon River, and he stated if the feasibility study identifies a feasible location for a bridge crossing but there are concerns with that location, then the Council will have discussions and take everything into consideration as they determine how to move forward.

Danielle Stull, 3530 Commerce Drive, noted the scope of services within the professional services agreement lists a number of project assumptions. She expressed concerns that this might not truly be a feasibility study, because one of the project assumptions states "The study will include two crossings of the Raccoon River, one approximately 1.6 miles west of I-35 and one approximately 1.0 mile east of I-35."

Mark Cullen, 3428 Scenic Valley Drive, inquired if the City has done any traffic studies.

Mr. Hemesath responded the City has not conducted a traffic study for any location where a bridge might go, as it makes more sense to conduct a traffic study once a potential bridge crossing location could be located; however, the traffic engineers have determined there is a need for an additional bridge crossing over the Raccoon River somewhere between 1<sup>st</sup> Street and Grand Prairie Parkway.

Council member Loots expressed support for the feasibility study, as its purpose is to provide information, but it doesn't necessarily mean the City Council will vote to construct anything. He stated he would never support constructing a road over Purple Martin Lake.

Mayor Pro tem Trevillyan stated he did not support the feasibility study, because he believes it is only common sense that there is no feasible location for a bridge crossing over the Raccoon River.

## On Item 3. Council/Manager/Other Entities Reports:

Council member Hardman reported the City recently kicked off the Community of Care campaign, which is intended to encourage the residents and business within our community to demonstrate care for others within our community. She expressed appreciation to the Police Department for their initiative to pack the patrol cars with donated items for West Des Moines Human Services. She also reported she attended a ribbon cutting ceremony for Merchants Bonding Company.

Council member Hudson reported the City collaborated with the West Des Moines Community School District to hold the kick-off event for the Community of Care campaign on Thursday, October 3<sup>rd</sup>. He also reported early voting for the November 5<sup>th</sup> general election will be starting in the next couple weeks.
