West Des Moines City Council Proceedings Monday, September 16, 2024

Mayor Russ Trimble opened the regularly scheduled meeting of the City Council of West Des Moines, Iowa, in the Council Chambers of the West Des Moines City Hall on Monday, September 16, 2024 at 5:30 PM. Council members present were: G. Hudson, D. Loots, M. McKinney, and K. Trevillyan.

City Clerk Ryan Jacobson stated staff recommends the agenda be amended to remove Item 5(b) Ashworth Road Design Criteria, which staff intends to bring back for Council consideration at a future meeting.

Council member Trevillyan requested that staff provide notification of that Council meeting date to everyone that had received notification of the September 10th public meeting regarding Ashworth Road.

Council member Hardman arrived at 5:32 p.m. The attendance was re-taken. Council members present were: R. Hardman, G. Hudson, D. Loots, M. McKinney, and K. Trevillyan.

On Item 1. Agenda. It was moved by McKinney, second by Hudson approve the agenda as amended.

Vote 24-365: Hardman, Hudson, Loots, McKinney, Trevillyan...5 yes Motion carried.

On Item 2. Public Forum:

Jeannine Ritchie, Dallas County Attorney, reported there will be a bond referendum on the November 5th election ballot for Dallas County voters to fund the construction of a proposed criminal court building, which is needed because the county has outgrown the Dallas County Courthouse. She stated the proposed new criminal court building would be located on U.S. Highway 6 on the east side of Adel, and it would serve as a second facility in addition to the Dallas County Courthouse, which would remain in operation.

Tom Stull, 3530 Commerce Drive, expressed concerns about Item 4(n)3 Professional Services Agreement - Raccoon River Bridges Feasibility Study, and he suggested that the study should exclude areas east of I-35. He noted there have been discussions in previous years about a potential bridge across the Raccoon River in that area, but there were significant environmental concerns with a bridge being constructed there.

Reike Plecas, 1001 7th Street, stated he was disappointed that the building at 122 5th Street was demolished. He expressed support for economic development projects in the Valley Junction Business District, but he requested that the Council ensure any future development projects in

that area would honor its history.

On Item 3. Council/Manager/Other Entities Reports:

Council member Trevillyan reported he attended the grand opening of TopGolf, which was well attended, and he stated it is a great facility for providing entertainment to our city's residents and visitors.

Council member Hardman congratulated TopGolf for their ribbon cutting ceremony. She also reported she attended a ribbon cutting ceremony for Des Moines University, which was the most well attended ribbon cutting ceremony she has ever attended. She also attended the Diversity Equity and Inclusion Workplace Excellence Awards ceremony, hosted by the West Des Moines Chamber of Commerce, and she congratulated the West Des Moines Human Rights Commission for receiving the DEI Award in Government. She also reported she attended Illumifest, and she commended the Parks and Recreation department for coordinating a successful event.

Council member McKinney congratulated TopGolf and Des Moines University for their ribbon cutting ceremonies. He expressed appreciation to Mayor Trimble for his leadership as chair of the Des Moines Area Regional Transit Authority, as the organization navigates through financial challenges and the withdrawal of two member cities. He also expressed his desire for the City to enforce the design guidelines for the Valley Junction Business District to ensure any new development project would honor the history of that area.

Council member Hudson congratulated TopGolf and Des Moines University for their ribbon cutting ceremonies, and he commended the Parks and Recreation department for coordinating Illumifest. He reported he attended a meeting of the Greater Des Moines Convention and Visitors Bureau Executive Board, and he expressed support for partnerships like these among metro cities because we are stronger together. He also reported that Election Day will be on Tuesday, November 5th, and he encouraged everyone who is eligible to get themselves registered to vote.

Mayor Trimble thanked Mayor Pro tem Trevillyan for filling in for him while he was travelling out of state. He reported the Des Moines Area Regional Transit Authority Board is exploring paths forward to continue providing public transit as efficiently as possible for those who need that service.

On Item 4(f) Approval of Conflict Waiver with Ahlers & Cooney, P.C. Regarding Waukee Community School District

Council member Loots expressed concerns that the proposed conflict waiver prepared by Ahlers & Cooney states "...our firm's representation of the District on the matter will be directly adverse to City because they are concurrent representations." He inquired why staff is recommending approval of this conflict waiver and not seeking different counsel on this matter.

Jessica Grove, Deputy City Attorney, responded that Ahlers & Cooney would prepare the documents related to the urban renewal area for this development, but the City's attorneys on staff would prepare the documents related to the development agreement. She noted the Waukee School District will be signing a similar conflict waiver. She also noted the attorneys working with the City on the urban renewal area are different attorneys than those that will be working with the Waukee School District on the negotiation of the development agreement, but they all work for Ahlers & Cooney.

Council member Loots stated he will not support this conflict waiver, because he is not comfortable with the appearance of a conflict of interest.

It was moved by Trevillyan, second by Hudson to approve Item 4(f) Approval of Conflict Waiver with Ahlers & Cooney, P.C. Regarding Waukee Community School District.

On Item 4(n)3 Approval of Professional Services Agreement - Raccoon River Bridges Feasibility Study

Note: The council communication for this item inaccurately indicated that the Public Services Subcommittee recommended approval of this agreement; however, it was presented to the subcommittee as an informational item and no recommendation was made.

Council member Trevillyan expressed support for removing the South 35th Street and South 50th Street corridors from this study, because he does not believe it would make any sense to locate a bridge over the Raccoon River along either of those corridors. He noted they had already been considered in previous years and were deemed not feasible at the time.

Brian Hemesath, City Engineer, explained that this study would determine the feasibility of all potential locations for bridges across the Raccoon River, including areas west of I-35 and east of I-35. He reported that from an engineering perspective, the ideal location for a bridge on the east side of I-35 would be one that could most easily connect to the interchange of SE 35th Street and Iowa Highway 5. He stated staff will share with the consultant the history from what was considered in previous years regarding the South 35th Street and South 50th Street corridors. He also noted if any bridge is constructed on the east side of I-35, it would only be along the South 35th Street or South 50th Street corridors, but it would not be both corridors. He also explained that this professional services agreement is for an amount not to exceed \$140,000, but it is necessary because the Engineering Services department does not have the expertise on staff that is needed to complete this feasibility study.

Mayor Trimble expressed support for this professional services agreement because he believes a bridge over the Raccoon River would be beneficial from an economic development perspective, and it is important to determine whether or not each potential bridge corridor would be feasible from an engineering, financial, and political standpoint.

Council member Trevillyan stated the Council also needs to take into consideration the historical significance of the properties that could be impacted, as he noted Mr. Stull's property dates back to the 1870's.

Council member McKinney expressed support for this professional services agreement, and he agreed that a bridge over the Raccoon River would be beneficial from an economic development perspective. He stated it would be important to gain an understanding of the pros and cons for each potential bridge corridor; however, he would not support any option that would disrupt Mr. Stull's property.

Council member Hudson expressed support for this professional services agreement, but he encouraged staff, if it is determined early in the process that the South 35th Street and/or South 50th Street corridors would not be feasible for any reason, they should not proceed with the full feasibility study for those corridors, so that the total cost of the study could be reduced.

Mayor Trimble noted a bridge over the Raccoon River would also be beneficial from a public safety perspective.

Tom Stull, 3530 Commerce Drive, expressed support for utilizing a consultant's expertise for this feasibility study, but he reiterated that he believes the areas east of I-35 should be excluded. He noted when a bridge at South 35th Street was considered in previous years, the Iowa Department of Natural Resources was opposed to a bridge along that corridor, as it would have impacted the west side of Walnut Woods State Park. He also noted the Iowa Department of Transportation was opposed to a bridge, as they desired to keep city traffic on city streets and off Iowa Highway 5. He suggested holding discussions with all these stakeholders before spending the money for this feasibility study.

It was moved by Trevillyan to approve Item 4(n)3 Approval of Professional Services Agreement - Raccoon River Bridges Feasibility Study, with an amendment to exclude the South 35th Street and South 50th Street corridors from the study. Motion died for lack of second.

It was moved by Hudson, second by McKinney to approve Item 4(n)3 Approval of Professional Services Agreement - Raccoon River Bridges Feasibility Study, as recommended by staff.

Council member Loots expressed support for this professional services agreement; however, he would not support any option that would disrupt Mr. Stull's property.

Council member Trevillyan requested that staff provide notification of the feasibility study to all property owners in the Commerce area so they have an opportunity to provide input as part of the study.

Mayor Trimble expressed concerns that such a notification could set a precedent the City may not want to set, so consideration will need to be given on how to do that.

Council member Trevillyan inquired why the condemnation award amount for one of the properties is \$15,985 above the City's highest offer.

City Attorney Greta Truman responded the condemnation went through a contested hearing with the condemnation commission, who has the ability to award the condemnation in an amount above the City's highest and best offer.
