West Des Moines City Council Proceedings Monday, February 20, 2023

Mayor Russ Trimble opened the regularly scheduled meeting of the City Council of West Des Moines, Iowa, in the Council Chambers of the West Des Moines City Hall on Monday, February 20, 2023 at 5:30 PM. Council members present were: G. Hudson, D. Loots, M. McKinney, and K. Trevillyan.

On Item 1. Agenda. It was moved by Trevillyan, second by Hudson approve the agenda as presented.

Julia McGuire, 919 45th Street, expressed appreciation to the Mayor and City Council for their continued support of the community garden.

On Item 3. Council/Manager/Other Entities Reports:

Steve Frevert, Executive Director of the Historic Valley Junction Foundation, and Stephanie Trannel, Board President for the Historical Valley Junction Foundation, presented an update on the organization's activities.

Council member McKinney reported he attended the West Des Moines Chamber of Commerce annual dinner, and it was a fantastic event.

Council member Hudson also stated that the West Des Moines Chamber of Commerce annual dinner was a great event. He reported the Finance and Administration Subcommittee met and discussed a project to improve the cell service at the MidAmerican Energy RecPlex and West Public Services Facility.

The City Clerk stated on a vote of 4-0, with one member abstaining and two members absent, the Plan and Zoning Commission recommended City Council approval of the comprehensive plan amendment.

It was moved by Trevillyan, second by Hudson to adopt Resolution - Approval of Comprehensive Plan Amendment.

Council member McKinney expressed appreciation to City staff for the time and effort they put into addressing the citizen concerns related to this development.

It was moved by Trevillyan, second by Loots to adopt Resolution - Approval of Plans and Specifications, Motion to Receive and File Report of Bids, and Resolution - Award Contract to The Waldinger Corporation.

On Item 7(a) Fox Ridge, Veterans Parkway and SE 25th Street - Approval of a Revised Preliminary Plat Creating 195 Lots for Single Family Residential Development and 136 Footprint Lots for Medium Density Residential Development, Six Outlots, and Nine Street Lots, initiated by D.R. Horton-Iowa, LLC and Forestar (USA) Real Estate Group, Inc.

It was moved by Loots, second by Hudson to adopt Resolution - Approval of Revised Preliminary Plat, subject to the applicant complying with all applicable City Code requirements and the conditions of approval listed in the Resolution.

Vote 23-051: Hudson, Loots, McKinney, Trevillyan...4 yes Motion carried.

On Item 7(b) Ashworth Road Restriping, 1st Street to 19th Street, initiated by the City of West Des Moines.

Mayor Trimble stated staff is recommending restriping this segment of Ashworth Road to convert it into three 12-foot lanes, studying how it performs, and then making a decision for the roadway going forward.

Council member Trevillyan noted the council communication indicates staff is recommending the performance be observed for "a stretch of time." He expressed a desire to specify the length of time for the observation period, and he expressed support for an observation period of 12 months in order to gather sufficient data during all seasons.

It was moved by Trevillyan, second by Loots to adopt Motion - Approval of Design Criteria, with an amendment to specify the length of the observation period as a minimum of 12 months.

Brian Hemesath, City Engineer, responded to questions from the Council, stating the roadway would not be able to be restriped until July 2023, due to significant construction work occurring

on 8th Street until that time. He stated staff would prefer to allow for a six-month observation period until January 2024, to allow sufficient time to acquire all the necessary right-of-way and include the project in the 2025 construction season. He noted, if the observation period were to last until July 2024, he not confident the project could be included in the 2025 construction season.

Council member Loots expressed a desire to leave the timeframe of the observation period open to staff discretion.

Del Christenson, 932 32nd Street, inquired if the widening of Ashworth Road, between 19th Street and 23rd Street, would be constructed in conjunction with the restriping from 1st Street to 19th Street.

Mayor Trimble responded the widening will not be done in conjunction with the restriping. He stated the City Council will review the data from the observation period prior to making a decision on what to do with the roadway going forward.

Charlotte Weisenhorn, 1527 Ashworth Road, stated traffic on Ashworth Road is very different between the summer months and the school year months. She expressed support for an observation period of nine months.

Council member Hudson expressed a preference for an observation period of nine months.

Motion failed.

It was moved by Trevillyan, second by Hudson to adopt Motion - Approval of Design Criteria, with an amendment to specify the length of the observation period as a minimum of nine months.
