West Des Moines City Council Proceedings Monday, November 4, 2024

It was moved by McKinney, second by Trevillyan to consider the first reading of the ordinance.

M.J. Hoag, 413 2nd Street, spoke in support of the proposed salary increases for the Mayor and City Council, stating he believes they are long overdue. He believes the increases will help the salaries keep pace with inflation, and, considering the amount of time the Mayor and Council put

into fulfilling their duties, he would support the increases being greater than what has been proposed. He also stated the increased salaries will help make it easier for those in the future who consider serving in those capacities.

Council member Hudson spoke in support of the proposed salary increases for the Mayor and City Council, especially because it will not take effect until January 1, 2028, after all the current elected officials will have had to face re-election.

Mayor Trimble noted these proposed salaries would be in line with comparable cities around Iowa.

Council member Loots stated he will not support the proposed salary increases for the Mayor and City Council, because if the purpose of these increases is to expand who could run for office, he does not believe the \$1,000 increase is enough to have any impact on that. He noted none of the current elected officials are doing it for the money.

Council member Hardman spoke in support of the proposed salary increases for the Mayor and City Council, because the elected officials devote a significant amount of time to fulfilling their duties and attend many ceremonial events at their own expense, so the increased salaries could help defray some of those costs.
