The regular meeting of the West Des Moines Public Arts Advisory Commission was called to order on Thursday, October 24, 2024, at 5:30 p.m. by Chair Mathrubutham.

On Item 1. Approval of Agenda

Moller moved to approve the agenda as presented. Crane seconded. Motion carried unanimously.

On Item 2. Citizen Forum

No Report.

On Item 3. Approval of Minutes of August 22, 2024 Meeting

Kitner moved to approve the minutes as presented. Crane seconded. Motion carried unanimously.

On Item 4. Old Business

New Business

On Item 5A. Motion – Approval of Recommendation to City Council – FY 25-26 Public Art Fund Budget

Penning provided an overview of the FY 25-26 Public Art Fund Budget. As stated in the Master Plan, ten percent of the total valuation of the permanent collection will be allocated to a separate maintenance fund. WDMurals received an increase of \$5,000 to include two additional murals for the 2025 exhibit. After carrying over \$20,000 from the 24-25 consulting fees, the total allocated budget for the Legacy Woods Commissioned Work of Art #5 is \$170,000.

Penning discussed upcoming revenue sources including Hotel/Motel Tax and grant opportunities. In FY 24, an additional \$30,000 was approved, increasing the Hotel/Motel Tax annual giving to \$150,000. An amendment has been requested to continue allocating this amount to the Public Art Fund annually. Until the amendment is approved, \$120,000 is currently budgeted. Funding for larger projects such as the Legacy Woods public art piece may span over two fiscal years or more. Applications are continually being submitted for grants including those from BRAVO Greater Des Moines. Since it has been a couple of years, Mathrubutham agreed to present the Public Art Annual Report to City Council.

Crane moved to approve the FY 25-26 Public Art Fund Budget recommendation to City Council as presented. Kitner seconded. Motion carried unanimously.

On Item 5B. Motion – Approval of 2025 Art on the Campus Selection Committee

Ullestad updated the Commission on the five members recommended to serve on the Art on the Campus Selection Committee. The Commissioners will be Courtney Moller and Jeff Phillips. The three citizens will include Suzanne Allen, Rachel Terlop, and Patrick Luber.

Moller moved to approve the 2025 Art on the Campus Selection Committee as presented. Barrette seconded. Motion carried unanimously.

On Item 5C. Motion – Establish November/December Meeting Date – December 5 Penning stated that the November and December meetings are combined due to the holiday

scheduling conflicts. The proposed date is Thursday, December 5.

Kitner moved to approve establishing the November/December Meeting Date as December 5. Moller seconded. Motion carried unanimously.

On Item 5D. Motion – Approval of Public Art Donation – Jane Ingram Allen Artwork – Sedlacek Family

Ullestad stated that *Confluence* was donated by Jaey Sedlacek in honor of Brenda Sedlacek's service on the Public Arts Advisory Commission. The Sedlacek Family is interested in donating another piece from their private collection titled *3 Flags in Space* by artist Jane Ingram Allen. The artwork was purchased in 2001 for \$1,700.

Because this piece is composed of handmade paper, it will need to be protected from the elements and likely displayed inside a facility. Some recommended locations include City Hall, Police Station, Fire Station, and Human Services. A few added suggestions include the MidAmerican RecPlex, the Vets Room in Valley Junction Activity Center, and the future Legacy Woods Heritage Center. Public Services will store the artwork until a location is selected. The Commission will need to consider the 10 percent allocated to the maintenance fund and the cost of installation. The donation agreement will need to go to City Council for approval.

Kitner moved to approve the Sedlacek Family Public Art Donation as presented. Barrette seconded. Motion carried unanimously.

On Item 6C. Exhibition Committee

Ullestad stated that the Exhibition Committee will need to discuss how to proceed with *Progression* and the relocation of the spheres that were removed from the pond. Penning added that new landscaping will be installed at the Jamie Hurd Amphitheater that includes shorter native grass allowing *Progression* to be more visible. Crane suggested asking the artist for approval for the new placement of the spheres.

Limelight suffered vandalism on two consecutive nights. Figures were removed and the wiring was damaged. A decision will need to be made about replacing or modifying the lighting element.

Project Work Group Reports

On Item 7A. Legacy Woods Public Art Project

Crane commented that the Legacy Woods site preparation has progressed rapidly allowing the work group to visualize public art in that location. Ullestad reported that during the previous two meetings, the group discussed the property's history and performed a preference exercise to determine the project's direction. The agenda for the next meeting on November 6, will include the Artist Statement and the Call for Artists.

Penning stated that \$10,000 was received from the Iowa DNR to fund the volunteer tree-planting event held on October 5 at Legacy Woods. There were 79 different species of trees and over 50 volunteers. Ullestad commented that the Iowa DNR awarded a \$200,000 REAP Grant for Legacy Woods Nature Sanctuary. In addition to grant opportunities, funding is received through donations from the private sector.

Staff Reports

On Item 8A. Arts, Culture & Enrichment Supervisor

Ullestad stated that the Call for Artists for Art on the Campus is due Sunday, October 27. Currently, 22 applications have been submitted. The recipient of the Art on the Campus People's Choice Award was Sadagat Aliyeva for the artwork titled *Fire*. Teva Lackmann received Best in Show for the piece called *The Beauty in our Backyard* featured in the WDMurals exhibit. Ullestad invited the Commission members to attend the National Conference for the Arts meeting and the Youth Justice Initiative Ribbon Cutting Ceremony for the mural at the West Des Moines Police Department.

Ullestad mentioned that she met with the Waukee Public Arts Advisory Commission to discuss the artist selection process, temporary art exhibits, and other obstacles that could be encountered when forming a new commission.

On Item 8B. Superintendent of Recreation

Murphy stated that registration opens on November 5 for the Winter/Spring Program Guide. Des Moines Parent Family Favorite opened the voting for awards such as Best Parks and Recreation Department, Best Playground, and Best Aquatic Center. Penning will send the voting information to the Commission. Trevor Hoth started his new role as the Recreation Program/Facility Supervisor creating a vacancy for Recreation Coordinator. After reviewing over 100 applications, 11 interviews were scheduled to fill this position. 31 teams participated in the 2nd Annual Pickleball Tournament held by the Friends of West Des Moines Parks and Recreation. They have launched a new website that supports WDM Parks and Recreation initiatives.

On Item 8C. Director of Parks and Recreation

Penning commented that the budget deadline is this week. It reflects on the past year and shows the direction of where the Department is headed. The results from the citizen survey show that 95 percent of residents were satisfied with the quality of life.

WDMurals Overview

The West Des Moines Public Arts Advisory Commission and Parks and Recreation Department invite **Iowa artists** to submit a Mural Proposal to participate in the 5th annual WDMurals public art exhibit. WDMurals is a temporary, outdoor exhibit that includes murals painted on the entrance and exit walls of underpasses along trails in West Des Moines.

Exhibit Details




- A selection panel will blind-score mural proposals to choose up to 12 original artist/artist group mural proposals.
- A Best in Show mural will be selected and publicized. The selected mural will remain in place for one year after the end of the current year's exhibit. The Best in Show artist/artist group will receive a \$500 award.
- The WDMurals exhibit will be promoted on-site and in the local media*. Marketing efforts will include but not be limited to:
- 1. An identification plaque listing the artist name(s), mural title, and mural description will be placed at each mural site
- 2. An article in WDM Magazine (direct mailed to all WDM households and businesses)
- 3. News and information on the City of WDM website (www.wdm.iowa.gov)
- 4. WDM Parks and Recreation Department's Facebook and Instagram accounts
- The WDMurals exhibit is a listed feature on the Otocast app, a mobile audio guide. Selected artists are required to work with Otocast staff to record a short narrative about their mural

*The City of West Des Moines reserves the right to photograph and reproduce images of the murals on exhibit for promotional and educational purposes.

Installation of Artwork

Artists are responsible for all supplies, equipment, and labor necessary for the installation of their mural. Care must be taken to ensure the safety of trail users during installation



Mural Criteria

All proposed murals must be the original work of the artist in concept, composition, and execution. Artists' proposals will be selected by a selection panel* comprised of WDM Public Arts Advisory Commission members and local citizens, artists, and/or business epresentatives. The following criteria will be used in the selection process:



Mural proposals that speak to the theme of "Our Friends and Family"

o Artists are asked to include an artist statement describing their artistic interpretation of the theme in the mural proposals

- Mural proposals that are suitable for public viewing
- Mural proposals that create a sense of discovery, surprise, imagination, and emotional connection
 - Mural proposals that are aesthetically and photographically pleasing
- Murals must be created using only spray, acrylic based, and/or exterior paint

*Decisions by the selection panel are final and not open to negotiation. To support an authentic, rich, and diverse arts culture for all, the West Des Moines Public Arts Advisory Commission commits to championing policies and practices of cultural equity that empower a vibrantly diverse, inclusive, equitable community.

There is no limit to the number of mural proposals submitted by an artist.



ITEM: Motion - Approval of Artists and Artwork Locations - 2025 Art on the Campus

FINANCIAL IMPACT: Expense of \$30,000 for the artist stipends (\$2,500 per work of art) and \$500 for the People's Choice Award for a total of \$30,500. This amount is included in the FY 24-25 budget.

SYNOPSIS: The Commission is sponsoring the 13th temporary "Art on the Campus" exhibit from April 15, 2025, to November 15, 2025. An "Art on the Campus" selection committee meeting was held on Monday, November 11, to review and score 46 proposals that were submitted by 26 artists from Iowa (14), Illinois (4), Nebraska (2), Missouri (2), Minnesota (3), and Wisconsin (1). Of the 26 artists, 13 were new and 13 were returning artists.

The selection committee members included: Courtney Moller (Commission member), Rachel Terlop (citizen), Patrick Luber (Citizen), and Suzanne Allen (Citizen), and Jeff Phillips (Commission member).

Twelve entries were selected to be temporarily installed around the pond on the city campus. The committee's recommendations include:

SYNOPSIS: A Request for Artist Qualifications has been developed by the Legacy Woods Public Art Project Work Group for a permanent work of art to be sited on public property within the confines of the Legacy Woods master site plan. The Request for Artist Qualifications is attached for review, but highlights of the main elements include the following:



SELECTION & PROJECT CRITERIA

Phase One

Finalists will be chosen based on the following factors:

- Quality of the letter of interest.
- Quality of work samples submitted.
- Artist/feam's capacity to complete the project, assessed through their biography and previous experience.

Phase Two

Evaluation of artworks proposed by finalists will depend on these criteria:

- Alignment with the Legacy Woods Public Art Statement (refer to earlier details).
- Engagement through interactive features.
- Aesthetic appeal.

- Must require minimal upkeep, pose no safety risks to viewers, and be durable enough to withstand local weather conditions.
- Should be visually appealing both during the day and at night, throughout all seasons.
- Installation must occur on public property within the designated Legacy Woods site plan; artists may suggest one or multiple locations for their artwork.
- The proposal must demonstrate a strong level of community engagement integrated into the artist's final development (please address this in the letter of interest).
- Projects may consist of one or multiple artworks.

SELECTION PROCESS OVERVIEW

We invite artists who fulfill the eligibility criteria to submit their qualifications. All submitted materials will undergo a pre-screening process to ensure compliance with the eligibility requirements. The Work Group will evaluate the qualified applications and select up to three finalists or finalist teams for interviews in West Des Moines. The City of West Des Moines will cover travel expenses related to the interview process. Finalists will receive further details about the interviews.

After the in-person interviews are completed, one artist or artist team will be selected for the commission to create, fabricate, and install a permanent artwork. Additional guidelines will be provided to the finalists. Please refer to the included timeline for more information.

The decisions made by the Work Group are conclusive and non-negotiable. In order to foster a genuine, vibrant, and diverse arts culture that benefits everyone, the West Des Moines Public Arts Advisory Commission is dedicated to promoting cultural equity policies and practices that empower a dynamic, inclusive, and equitable community.

FINANCIAL IMPACT: Ten percent of the artwork's value will be allocated to the public art maintenance fund.

SYNOPSIS: Jaey and Brenda Sedlacek have generously proposed donating a piece from their private collection to enhance the City's permanent public art collection. (Brenda served as a Commissioner on the West Des Moines Public Arts Advisory Board from 2011 to 2023. The Sedlacek family previously contributed the artwork titled "Confluence," which is displayed in front of City Hall, in 2022.) The artwork being offered, named "3 Flags in Space," was created by artist Jane Ingram Allen in 1992 and is appraised at \$1,700.

PUBLIC ARTWORK DONATION AGREEMENT

THIS AGREEMENT is made and entered into on date last signed below between the City of West Des Moines, an lowa municipal corporation, acting on behalf of the City of West Des Moines, Public Arts Advisory Commission ("OWNER") and Jaey/Brenda Sedlacek, ("DONOR"). The OWNER'S REPRESENTATIVE shall be the Director of Parks and Recreation or their designee.

1. Purpose of Agreement

DONOR, as the sole owner of the artwork entitled "3 Flags in Space" ("ARTWORK") hereby donates the ARTWORK to the OWNER ("Agreement"). Exhibit A to this Agreement describes the ARTWORK and includes photographs of the ARTWORK.

In consideration of the DONOR's donation of the ARTWORK to the OWNER, the OWNER agrees to publicly display the ARTWORK in/at <u>West Des Moines City Hall</u> for a period of at least five years and to credit the DONOR on a sign or plaque posted with the ARTWORK.

2. **DONOR's Representations and Warranties**

- a. The DONOR represents and warrants that the DONOR is the sole owner of the ARTWORK. The DONOR further represents and warrants that the ARTWORK is free and clear of any liensand that there are no outstanding disputes in connection with property rights, intellectual property rights, or any other rights in the ARTWORK or parts of the ARTWORK.
- b. The DONOR represents and warrants that the ARTWORK will not pose a danger to public property, health or safety even with the possibility of misuse, if such misuse is in a manner that was reasonably foreseeable at any time during the term of this Agreement.
- C. The DONOR represents and warrants that general routine maintenance and repair of this ARTWORK will maintain the ARTWORK within an acceptable standard of public display.
- d. The DONOR represents and warrants that the installation and removal of the ARTWORK will not damage or cause the ARTWORK to fall below an acceptable standard of public display as determined by the OWNER.
- e. If the location specified in section 1 above is outside, the DONOR represents and warrants that foreseeable exposure to the elements and general wear and tear will cause the ARTWORK to experience only minor, repairable damage and will not cause the ARTWORK to fall below an acceptable standard of public display as determined by the OWNER.

3. Intellectual Property and Public OWNER Rights

a. OWNER's Intellectual Property License. The DONOR grants to the OWNER, and to the OWNER'S REPRESENTATIVE, authorized contractors and assigns, an unlimited, non-exclusive and irrevocable license to do the following with respect to the ARTWORK:

- (1) Use and Display. OWNER may use and display the ARTWORK.
- Reproduction and Distribution. The OWNER may make and distribute, and authorize the making, display and distribution of, photographs and other two-dimensional reproductions of the ARTWORK. The OWNER may use such reproductions for any OWNER-related purpose, including, but not limited to, advertising, educational and promotional materials, brochures, books, flyers, postcards, print, broadcast, film, electronic and multimedia, and catalogues or similar publications. The OWNER shall ensure that such reproductions are made in a professional and tasteful manner, in the sole and reasonable judgment of the OWNER.
- b. Third Party Infringement. The OWNER is not responsible or liable for any third-party infringement of any copyright to the ARTWORK held by the DONOR and is notresponsible for protecting the intellectual property rights of the DONOR. The DONOR understands and agrees that the ARTWORK will be displayed in a public place and may be photographed, filmed, or otherwise recorded for any purpose without any restriction by the OWNER.
- c. Credit. All reproductions by the City shall contain a credit to the DONOR and artist.
- d. Trademark. In the event that the OWNER's use of the ARTWORK creates trademark, service mark or trade dress rights in connection with the ARTWORK, the OWNER shall have an exclusive and irrevocable right in such trademark, service mark, or trade dress.
- e. Alteration. The OWNER agrees that it will not intentionally damage, alter, modify, or change the ARTWORK without the prior written approval of the DONOR.
- f. Release. The DONOR hereby releases the OWNER from any claims or demands associated with the ARTWORK including, without limitation, the right of privacy or publicity and DONOR hereby waives any rights arising from the Federal Copyright Act, including, but not limited to the Visual Artists Rights Act, 17 U.S.C §§106A and 113(d)("VARA").

4. Indemnification

- a. The DONOR agrees to indemnify and hold harmless the OWNER, its subdivisions, officials, employees and agents from any liabilities, willful or non-willful acts of negligence by the DONOR or the DONOR's agents or employees, or any or all elements of loss, theft, mutilation, vandalism or other damage (including those caused by acts of God) that may befall the ARTWORK during any activities related to the planning, creation, or delivery of the ARTWORK.
- b. Upon installation of the ARTWORK, the OWNER shall indemnify and hold harmless the DONOR from claims or liabilities relating to the maintenance of the site at which the ARTWORK is installed, which claims or liabilities arise from and after the date of installation of the ARTWORK.
- c. The DONOR shall indemnify, protect, defend and hold harmless the OWNER and its subdivisions, officials, employees and agents from and against all liabilities, obligations, losses, damages, judgments, costs or expenses (including legal fees and costs of investigation)

(collectively "Losses") arising from, in connection with or caused by: (a) any personal injury or property damage caused, directly or indirectly, by any act or omission of the DONOR and/or the DONOR's agents, employees, or assigns; (b) any infringement of patent, copyright, trademark, trade secret or other proprietary right; or (c) any infringement of the DONOR's rights under 16 U.S.C. § 106A, 16 U.S.C. § 113, Civil Code §§ 987 et seq, or similar state, federal, or international law. Notwithstanding the foregoing, the DONOR shall have no obligation under this Section with respect to any Loss that is caused solely by the active negligence or willful misconduct of the OWNER and is not contributed to by any act or omission (including any failure to perform any duty imposed by law) by the DONOR.

5. **Termination of Agreement**

Prior to the expiration of the display period set forth in Section 1 of this Agreement, the OWNERmay decide to remove the ARTWORK from public display and terminate this Agreement. The OWNER shall provide written notice within thirty (30) days of the intent to remove the ARTWORK and terminate the Agreement to the DONOR at the address listed in Section 14 of this Agreement.

6. Installation and Removal of ARTWORK

The OWNER will have authority over the installation and removal of the ARTWORK. The OWNER and the DONOR have jointly developed a plan for installation of the ARTWORK in a manner that is cost-effective as well as protective of OWNER'S property and the ARTWORK. That plan is attached to this Agreement as Exhibit B. The OWNER shall take all actions reasonably necessary to facilitate and permit implementation of the plan described in Exhibit B, including making the ARTWORK available on a timely basis. The OWNER shall also be solely responsible for any and all activities identified in Exhibit B. The OWNER shall be solely responsible for removal of the ARTWORK.

If the ARTWORK can be removed from public display without significant damage to the ARTWORK or the site where the ARTWORK is installed, the OWNER shall take reasonable precautions to minimize alteration of the ARTWORK during removal. If the ARTWORK cannot be removed from public display without alteration of the ARTWORK (e.g., it is incorporated into a building), the DONOR waives any and all such claims, and any rights granted under the Visual Artists Rights Act, or similar law, against the OWNER, its agents, officers and employees, for alteration of the ARTWORK.

7. **Donation**

In accordance with the OWNER's donation policy, the parties agree that:

- The OWNER will provide the DONOR with a donation receipt indicating the estimated value of the ARTWORK within thirty (30) days upon execution of this Agreement.
- b. The DONOR's contribution to the OWNER will be recognized publicly as described above.
- c. Except as provided in this Agreement, the OWNER may use the ARTWORK in anymanner at its sole discretion and the DONOR has no right or obligation to control the OWNER's use of the donation.
- d. The DONOR has not and will not receive any goods or services in exchange for the donation

and the OWNER will not grant any extra consideration to the DONOR in relation to OWNER procurement, regulatory matters, or any other business, services, or operations of the OWNER.

- e. The DONOR confirms that this donation is not made at the behest of a City Council Member or of any member of the Public Arts Advisory Commission or staff of the Parks and Recreation Department.
- f. Title to the ARTWORK shall pass to the OWNER upon execution of this Agreement.

8. Choice of Law & Venue

This Agreement shall be governed by the laws of lowa. The venue for all litigation or other disputes relative to this Agreement shall be the District Court for the County of Polk, Iowa.

9. Captions

Section headings are for reference only and shall not be used to interpret this Agreement.

10. Severability

If any provision hereof is found to be invalid or unenforceable, such finding shall not affect the validity of any other provision hereof; and such provision shall be enforced to the maximum extent possible so as to affect the intent of the parties.

11. No Waiver

Any failure to enforce any right or to require performance of any provision of this Agreement shall not be considered a waiver of such right or performance.

12. Entire Agreement

This Agreement, including the attached and incorporated exhibits, contains the entire agreement between the parties, and supersedes all other oral or written provisions.

13. Modifications and Amendments

No amendment or modification to this Agreement shall be effective unless it is in writing and signed by authorized representatives of each of the parties hereto.

14. Notices

Unless otherwise indicated in this Agreement, all written communications sent by the parties may be made by U.S. Mail, e-mail, or phone, and shall be addressed as follows:

a. if the OWNER, to:

ARTIST Biography: Jane Ingram Allen is an installation artist who does art projects around the world using hand papermaking with natural materials and collaborative processes to raise public awareness about environmental issues. Jane has received numerous awards for artist-in-residencies and community public art projects in the USA, the Philippines, Japan, Nepal, Brazil, China, Tanzania, Taiwan, Turkey and Indonesia. She was a Fulbright Scholar artist-in-residence in Taiwan in 2004 and 2005 and a Fulbright Specialist in Turkey in 2015. She received Puffin Foundation Grants in 2003, 2007, 2011 to support her art installations in New York and MA. She has also received grants from the Chenven Foundation, City of Sacramento, City of Santa Rosa, and other organizations around the world to support her work. For her artworks Jane begins by making handmade paper from local plant waste and uses materials and techniques that contribute to sustainable living and improve the environment. Jane is a former college art instructor and currently writes about art for SCULPTURE and other art magazines as well as doing independent curating. Since 2012 she has been based in Santa Rosa, CA, and continues her work in the US and internationally.

ARTIST Statement: My art aims to foster public awareness of environmental issues, with collaborative and participatory processes in mixed media multi-part installations. I use all natural and biodegradable materials such as handmade paper I make from local plant waste materials and seeds to produce continually evolving artworks that transform with nature as a partner. In my recent "Living Quilts" outdoor installations, the handmade paper dissolves over time becoming compost to nourish the earth, and the seeds sprout and grow to produce food and habitat for wildlife as well as aesthetic experiences for humans. The sculptural structures with my living, growing installations are made of wood and branches and last well for many years, and the artworks continue to change and evolve with time. These works comment on our vain hope for permanency in art and our desire to conquer nature rather than exist in harmony with the earth. With recent projects I am focusing on water and our current climate crisis, bringing attention to our dire circumstances, with too little water and too much water, and projecting hope for a better future.
